Dear Randy;

The OCD policy concerning wells that are not in compliance with OCD rules at the time of change of operator is that such wells must be brought into compliance prior to OCD approval of the transfer. Wells are brought into compliance by:

- (1) Returning the well to production,
 - (2) T & A the well,
 - (3) P & A the well, or
 - (4) Providing additional surety that the well will be P & A.

The purpose of this policy is not to impede the transfers of property but to ensure that all wells are properly P & A. It is the current operator's responsibility to ensure that the wells are brought into compliance; however either party may perform such action.

The Form C-104 Change of Operator will not be approved until one of the above conditions has been met. Also, the total package of wells, both in and out of compliance, will not be approved until these conditions are met for all wells. The prior operator's bond will be released when the C-104's are approved. Failure to bring wells into compliance can result in the OCD calling a "show cause" hearing and P&A the well, foreclosing on the operator's bond and taking further legal action against such operator for the additional cost of plugging and any fines assessed.

The OIL CONSERVATION DIVISION DISTRICT II office in Artesia, New Mexico has received a C-104 for change of operator to JOHN A. YATES, JR. OIL OPERATOR. YATES PETROLEUM is the operator of record until the C-104 is approved by this office. Our records show that the State HC No. 1 well has not produced any oil or gas in the last twelve months. The C-104 will not be approved and your bond will not be released for this well until it is brought into compliance.

Please advise this office by 2/9/98 of your plans to bring this well into compliance. We appreciate your cooperation in this matter.
