Dear Mr. Catanach,

XTO Energy, Inc. requests approval to surface commingle gas production from the Armenta Gas Com C #1A and the Armenta Gas Com G #1. The Armenta Gas Com C #1A is a Mesaverde well drilled in 1983. The Armenta Gas Com G #1 is a new Fruitland Coal well drilled in December, 2001 and located approximately 190' southeast of the Armenta Gas Com C #1A. XTO plans to compress gas from both wells through a shared compressor. Having both wells on compression will help them overcome sales line pressure, maximizing their gas rates. Sharing a compressor will lower operating costs and reduce fuel gas usage versus setting two compressors and independently compressing gas from each well. This will extend the economic lives of both wells, thus increasing their ultimate recoveries.

A gas allocation meter will be set on the Armenta Gas Com G #1. The existing gas meter on the Armenta Gas Com C #1A will become the central distribution point (CDP) gas sales meter for both wells. The Armenta Gas Com G #1's gas production will be measured independently by its own gas allocation meter. The Armenta Gas Com C #1A gas production will be calculated by the difference between the CDP gas sales meter volume and the Armenta Gas Com G #1 gas allocation meter volume. The fuel gas usage will be allocated between the wells. The oil and water production from each well will be kept separate and not surface commingled.

The interest ownership between the two wells is not common. Notification of the proposed surface commingle was sent by certified mail to all working and royalty interest owners in both wells on January 9, 2002. One objection was received within the 20 day waiting period. Mr. Fred Armenta a royalty interest owner in the wells has protested the application. I have attached a copy of Mr. Armenta's letter. XTO responded to Mr. Armenta's objection on February 6, 2002 reiterating the advantages of surface commingling with a shared compressor and asking him to withdraw his objection (copy enclosed). If Mr. Armenta signs and returns the withdrawal of objection it will be forwarded to you and we would request administrative approval of this application. If Mr. Armenta does not response then we request a hearing on this application. Mr. Jim Bruce will be contacting you about getting on the docket.



**Armenta Gas Com C #1A & Armenta Gas Com G #1
Gas Allocation Formula**

The Armenta Gas Com C #1A's existing gas sales meter will be used as the central distribution point (CDP) gas sales meter for both wells. A gas meter will be set on the Armenta Gas Com G #1 and used as its allocation meter. See the attached proposed gas surface commingle installation diagram. The Armenta Gas Com G #1 allocation meter will separately measure its gas production. The Armenta Gas Com C #1A gas production will be calculated by difference between the CDP sales meter volume and the Armenta Gas Com G #1's allocation meter volume. Fuel gas usage will be allocated between the two wells. Williams Field Services is the gas transporter for these leases.

Armenta Gas Com C #1A gas production will be calculated as follows:

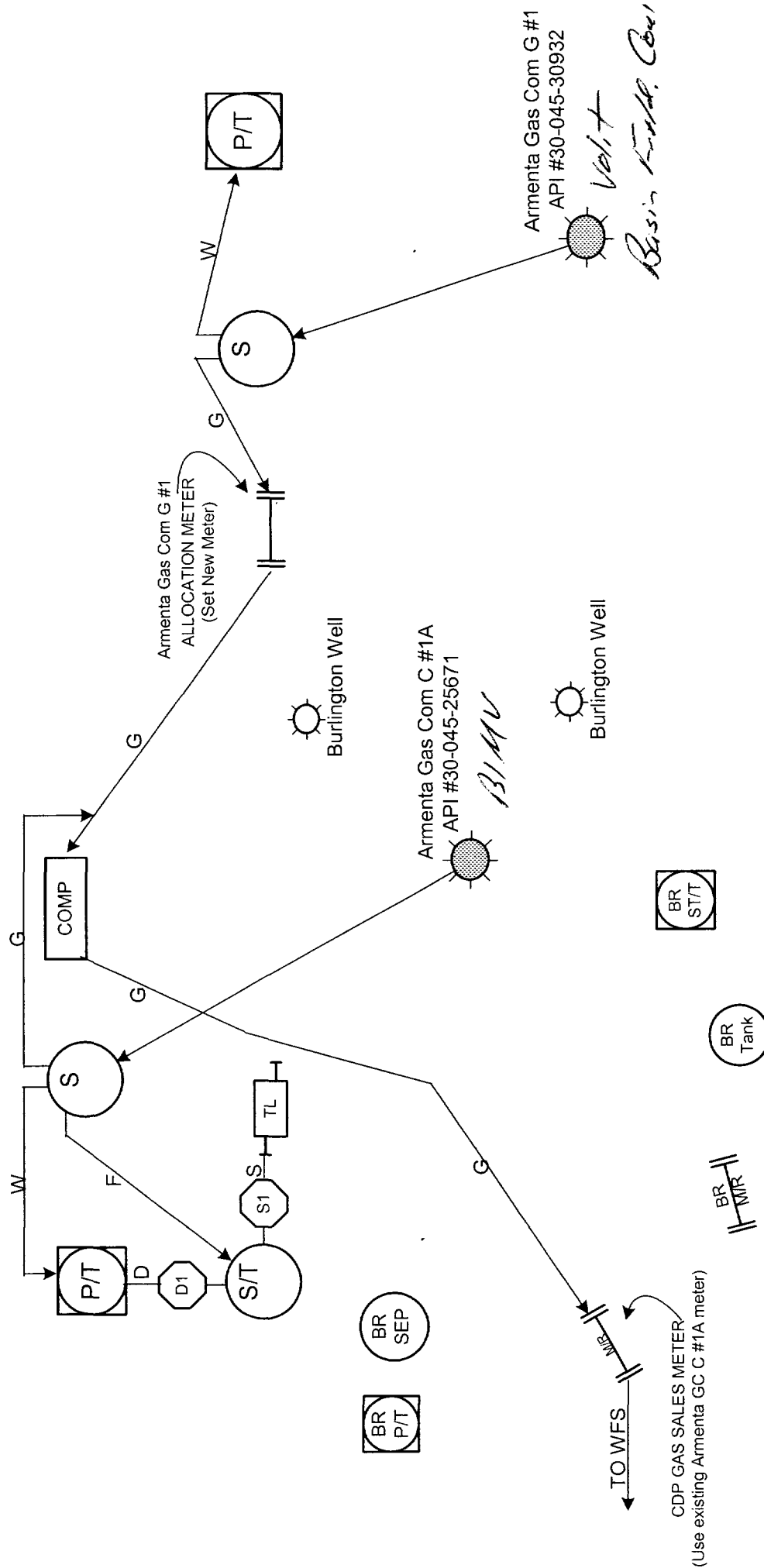
$$\text{Gas Prod.} = [\text{CDP sales meter vol.} - \text{Armenta Gas Com G \#1 allocation meter vol.}] + \text{Allocated fuel gas vol.}$$

Armenta Gas Com G #1 gas production will be calculated as follows:

$$\text{Gas Prod.} = \text{Armenta Gas Com G \#1 allocation meter vol.} + \text{Allocated fuel gas vol.}$$

The total fuel gas usage is estimated to be 14.4 MCFD for the compressor. During the winter if either well's separator water bath is heated, the fuel gas usage is estimated to be 1 MCFD for that well.

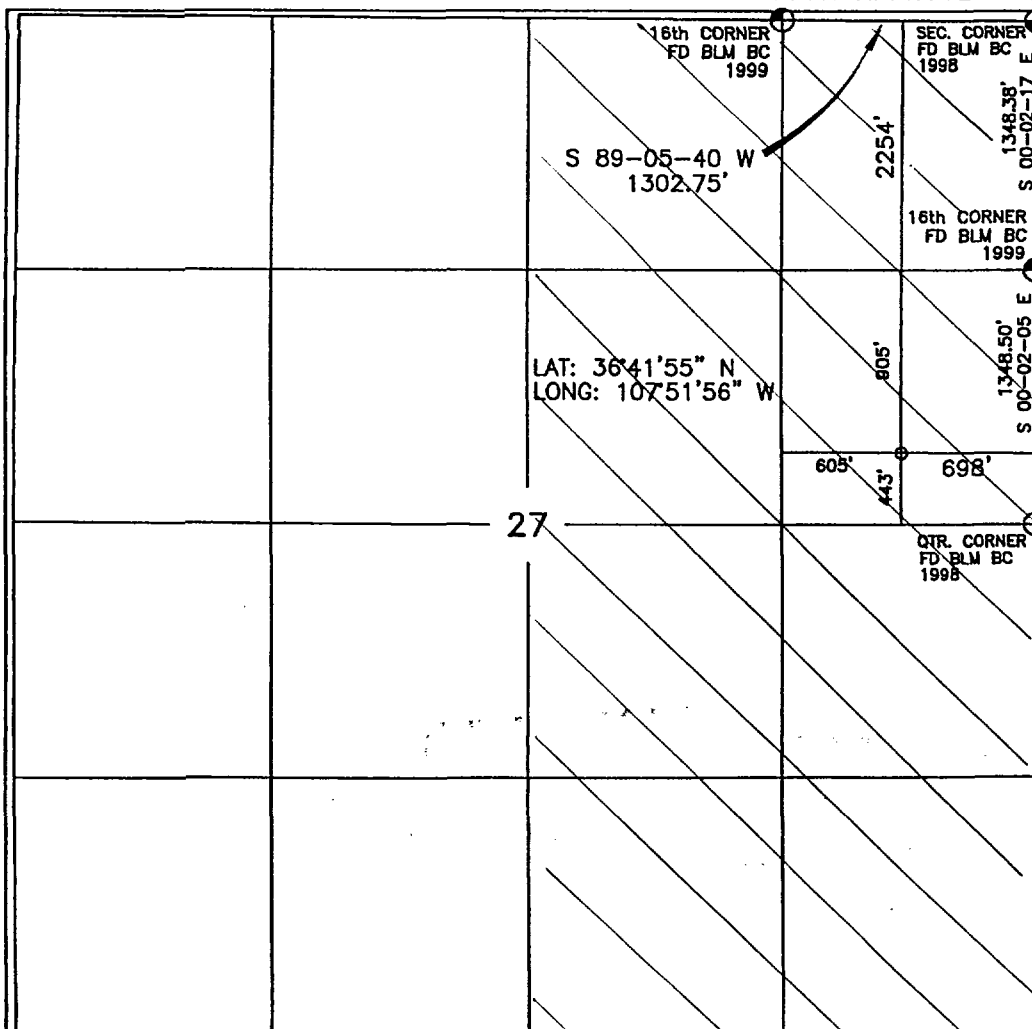

XTO Energy Inc. (formerly Cross Timbers Operating Company) plans to surface commingle gas production from the Armenta Gas Com G #1 (newly drilled Fruitland Coal well, API #30-045-30932) and the Armenta Gas Com C #1A (existing Mesaverde well), API #30-045-25671. We plan to produce the commingled gas through a new compressor that will be set on the Armenta Gas Com C #1A location. Sharing a compressor will lower operating costs and reduce fuel gas usage versus independently compressing gas from each well. The lower operating costs (vs. independent compression) resulting from a shared compressor will extend the economic lives of both wells, thus increasing their ultimate recoveries.

A gas allocation meter will be set on the Armenta Gas Com G #1. The existing gas meter on the Armenta Gas Com C #1A will be used as the central distribution point (CDP) gas sales meter for both wells. The Armenta Gas Com G #1 production will be measured independently by its own gas allocation meter. The Armenta Gas Com C #1A gas production will be calculated by the difference between the CDP gas sales meter volume and the Armenta Gas Com G #1 gas allocation meter volume. The compressor fuel usage will be divided between the wells. The oil and water production from each well will be kept separate and not surface commingled.

NMOCD requires all interest owners be notified prior to surface commingling when ownership is different between wells. Dear Mr. Armenta,

We have received your letter of objection to surface commingling the Armenta Gas Com G #1 (new drill Fruitland Coal well) with the Armenta Gas Com C #1A (existing Mesaverde well). I would ask you to withdraw your objection for the following reasons:

In your letter you raised concerns about the number of compressors on your property. Compression will be necessary on the existing well to allow it to continue to produce and on the new well to produce at a higher rate. Surface commingling gas production from the two wells will allow them to share a compressor.

In your letter you stated that you saw no benefit in surface commingling the wells. If a compressor is set on each well the operating cost would be higher than if the wells shared a single compressor. The higher operating cost of two compressors will cause the wells to reach their economic limit at a higher gas rate. This would result in a waste of the resource that a prudent operator would avoid.

Should you continue in your objection to surface commingling gas production from these two wells, we will request a hearing before the New Mexico Oil and Gas Conservation Division in Santa Fe, New Mexico. You will be able to be present and testify to your objection at this hearing. Should a hearing be necessary, you will be notified of the date and time of the hearing.
