














Devon Energy Production Company, L.P., Strawberry '7' Federal Com. #1












Yates Petroleum Corporation, Dragonfly 'ARX' State #1




Marbob Energy Corporation, MJ State #1




Kaiser-Francis Oil Company, Pure Gold 'A' Federal #1
