Arrington Oil & Gas, Inc., ("Arrington"), and TMBR/Sharp Drilling, Inc., ("TMBR/Sharp"), through their undersigned counsel, hereby notify the Division pursuant to the terms of Order No. R-11700-C (decretal paragraphs 16 and 17) of their voluntary agreement with respect to Arrington's participation in the TMBR/Sharp Blue Fin "25" Well No. 1. Such voluntary agreement was reached prior to entry of the Order and the parties agree that the terms of the Order shall be inapplicable to Arrington's interests.

Further, Arrington withdraws its application filed in Case No. 12,859 and withdraws any support previously provided to the applications filed in Case Nos. 12,841 and 12,860. David H. Arrington Oil and Gas, Inc. also withdraws its Application for Hearing De Novo filed on December 27, 2002 in Case Nos. 12,816, 12,841, 12,859 and 12,860 and states that it has no position regarding the disposition of those cases.
