4 Docket Number 28-02. Please note today's date, Thursday,
5 September 19th, 2002.

6 And at this time I will call Case Number 12,898,
7 which is the Application of Williams Production Company for
8 a nonstandard gas spacing proration unit and an unorthodox
9 subsurface gas well location in Rio Arriba County, New
10 Mexico.

11 Call for appearances.

12 MR. CARR: May it please the Examiner, my name is
13 William F. Carr with the Santa Fe office of Holland and
14 Hart, L.L.P. We represent Williams Production Company, and
15 I have a brief statement.

16 EXAMINER STOGNER: Any other appearances?

17 I believe this was advertised in the absence of
18 objection.

19 Do you have a statement, Mr. Carr?

20 MR. CARR: Mr. Stogner, in June of this year
21 Williams Production Company filed an administrative
22 application for a nonstandard gas proration unit and an
23 unorthodox subsurface gas well location in the Basin-Dakota
24 Pool.

25 The Division on June 24th advised Williams that

1 this was a type of an application that was not authorized
2 pursuant to the Rules for the Basin Dakota Pool and that
3 the case would be set on the August 1st OCD docket and
4 advertised that in the absence of objection it would be
5 taken under advisement.

6 It did come up August the 1st. It was taken
7 under advisement at that time.

8 During the process of drafting an order I was
9 advised that the case had been incorrectly advertised and
10 would have to be re-opened and re-advertised and set on
11 this date. So that's why we're here today.

12 Since there is no objection to the Application,
13 Williams requests that the case now be taken under
14 advisement and an order entered.

15 EXAMINER STOGNER: Okay, anything further in Case
16 12,898?


17 Then this matter will now be taken under
18 advisement.

19 Thank you, Mr. Carr.
