Re: Oil Conservation Division Case No. 12900: Application of Nearburg Exploration Company, L.L.C. for compulsory pooling and an unorthodox well location, Lea County, New Mexico.

Dear Ms. Wrotenbery;

On August 1, 2002, the Division entered Order No. R-11811 which granted the application of Nearburg Exploration Company, L.L.C. in the above-referenced case pooling all uncommitted interests from the surface to the base of the Strawn formation underlying the S/2 SW/4 of Section 10, Township 17 South, Range 37 East, NMPM, Lea County, New Mexico forming a standard 80-acre spacing and proration unit for all formations and/or pools developed on 80-acre spacing, which includes the Humble City-Strawn and Shipp-Strawn Pools.

The pooled units are to be dedicated to the Voyager-Shipp Well No. 1 (API No. 30-025-30386) which Nearburg proposes to re-enter and directionally drill from a surface location 990 feet from the South line and 330 feet from the West line (Unit M) of Section 10, to an unorthodox bottomhole location 860 feet from the South line and 1400 feet from the West line (Unit M) of Section 10. This unorthodox location was approved by Order No. R-11811.

Order R-11811 provides that in the event Nearburg does not commence re-entry and directional drilling operations on or before November 15, 2002, this pooling order shall be of no effect unless

Nearburg obtains a time extension from the Division Director for good cause shown.

Nearburg plans to re-enter and directionally drill the Voyager-Shipp Well No. 1 in the S/2 SW/4 of Section 10. However, it has encountered delays in obtaining necessary partner approvals and has determined that it will not be able to commence drilling until some time during the first quarter of 2003. Since it will be unable to commence drilling prior to the current deadline set by this pooling order, Nearburg Exploration Inc. Nearburg Exploration Company, L.L.C. therefore requests an extension of the provisions of Order No. R-11811 from November 15, 2002 until February 15, 2003.
