Dear Ms. Fischer:

Richardson Production Company proposes to drill a downhole commingled Fruitland Coal and Pictured Cliffs well on the captioned acreage. A recent check of the county records indicates that you own a 17.755 net acre unleased mineral interest within the spacing unit. The Navajo 14 #2 well will be located in the NE/4 of Section 14, Township 29 North, Range 14 West. The spacing unit for the Fruitland Coal will be the E/2, and the spacing unit for the Pictured Cliffs formation will be the NE/4.

Enclosed for your review is an AFE itemizing the estimated costs for the well. In the event you wish to participate in this drilling and completion attempt, please return an executed copy of the AFE to the undersigned by July 17, 2001. Upon receipt of your executed AFE, or by prior written request, we will forward an AAPL Form 610 Joint Operating Agreement for your review and execution, providing for, among other things, a 300%/100% nonconsent penalty and \$5000 drilling/\$500 producing overhead rates.

In the event you do not wish to participate, Richardson respectfully requests you elect one of the following options as to your interest:

1. Enter into an oil and gas lease that provides for a three year primary term with bonus consideration based on \$50.00 per net acre and a 12.5% royalty in the event of production
2. Sell all of your mineral interest for \$150.00 per net acre
