Stamped by OCD Representative Chris Williams on December 13, 2000. Approved Permit shows location at 990' FNL & 1817' FEL. Stamped that permit would expire 1 year from date of issuance unless drilling was underway.
- Copy of OCD Form C-103, Sundry Notices and Reports on Wells, requesting a renewal of the Permit for the State A #6 well. Stamped by OCD Representative Paul F. Kautz on September 19, 2001. Also signed by Apache Corp. Representative Harold Swain on September 10, 2001. Notation that permit was extended until December 13, 2002. Location shown on the form is 990' FNL & 1817' FEL.

- 6. Cover Letter and Executed Surface Damage Release for the State A #6 location. The Surface Damage release is signed by Apache Corp. Representative Glenn A. Otness, Land Manager and by a representative of Grimes Land Company on August 16, 2001. The cover letter is signed by the same Grimes Land Company Representative on August 29, 2001. Location shown on the release was at 990' FNL & 1817' FEL.
- 7. Revised 2002 AFE for drilling and completing the State A #6 well at 990' FNL & 1817' FEL, Sec. 32, T18S, R38E, Lea County, New Mexico.
- Copy of OCD Form C-103, Sundry Notices and Reports on Wells, showing Spud, Casing and Cementing Programs used during the drilling of the State A #6 well. Form was filed with the OCD in June, 2002. Stamped by OCD Representative Gary W. Wink on June 27, 2002
