3           EXAMINER STOGNER: Call the hearing to order for  
4   Docket Number 02-03. Today's date is Thursday, January  
5   23rd, 2003.

6           At this time I'll go through the continuances and  
7   dismissals.

8           On page 1, Case Number 12,992, this is the  
9   Application of San Resources, Inc., for compulsory pooling,  
10   San Juan County, New Mexico. This case will be continued


