1 WHEREUPON, the following proceedings were had at  
2 8:17 a.m.:

3 EXAMINER STOGNER: This hearing will come to  
4 order today for Docket Number 06-03. Please note today's  
5 date, Thursday, March 13th, 2003.

6 I'm Michael Stogner, appointed Hearing Examiner,  
7 one of the Hearing Examiners today. And Ted Apodaca from  
8 the legal staff in the Department is to my left today, and  
9 he'll be sitting in with me on this one case.

10 Okay, first page, Case Number 13,014, this is the  
11 Application of Matador E&P Company for compulsory pooling,  
12 Lea County, New Mexico. This case is continued to March  
13 27th.

14 Next one down, Case 13,006, this is the  
15 Application of Chesapeake Operating, Inc., for compulsory  
16 pooling, Lea County, New Mexico. This case will be  
17 continued to the April 10th docket.

18 Continuing over to the second page, Case Number  
19 13,008, this is the amended Application of Yates Petroleum  
20 Corporation for simultaneous dedication, Chaves County, New  
21 Mexico. This case is going to be continued and  
22 readvertised, or will be continued and readvertised, for  
23 the March 27th hearing.

24 Continuing down, Case 13,019, this is the  
25 Application of Yates Petroleum Corporation for approval of

1 its Caviness State Exploratory Unit in Lea County, New  
2 Mexico. This case will be dismissed.

3 The last one on this page, Case 12,998, this is  
4 the Application of NGX Energy for compulsory pooling and a  
5 nonstandard gas spacing and proration unit in Eddy County,  
6 New Mexico. This case is also dismissed.

7 Page 3, top of the page, Case 13,021, this is the  
8 Application of Mewbourne Oil Company for compulsory  
9 pooling, Eddy County, New Mexico. This case will be  
10 continued to the March 27th docket.

11 Down toward the end of the page, Case 13,010,  
12 this is the Application of Concho Oil and Gas Corporation  
13 for compulsory pooling, Lea County, New Mexico. This case  
14 will be continued to April 10th, 2003.

15 The last one on this page, 13,011, this is the  
16 Application of Concho Oil and Gas Corporation for  
17 compulsory pooling, Lea County, New Mexico. This case will  
18 also be continued to April 10th.

19 Page 4, top of the page, Case 13,022, this is the  
20 Application of Pogo Producing Company for approval of a  
21 pilot pressure maintenance project and to qualify the  
22 project for the recovered oil tax rate pursuant to the  
23 Enhanced Oil Recovery Act of New Mexico in Eddy County, New  
24 Mexico. This case will also be continued to April 10th.

25 Page 5, Case 13,025, this is the Application of

1 the New Mexico Oil Conservation Division through the  
2 Environmental Bureau Chief to revoke the permit of Crawford  
3 Treating Company to operate an oil treatment plant in Lea  
4 County, New Mexico. This case will be continued to April  
5 24th.

6 Case 13,026, this is also an Application of the  
7 Oil Conservation Division through the Environmental Bureau  
8 Chief to revoke the permit of Am-Bett Oil Company, Inc., to  
9 operate an oil treatment in Lea County, New Mexico. This  
10 case will also be continued to April 24th.

11 Case 13,027, this is another Application of the  
12 Oil Conservation Division through the Environmental Bureau  
13 Chief to revoke the permit of Jamar, Inc., to operate an  
14 oil treatment plant in Lea County, New Mexico. This case  
15 will also be continued to April 24th.

16 Are there other continuances or dismissals at  
17 this time?

18 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe,  
19 representing the Applicant. I have witnesses to be sworn.

20 MR. FELDEWERT: Mr. Examiner, Michael Feldewert  
21 with Holland and Hart. On the first page, Case Numbers  
22 13,015 and 13,016, the Applications of Paladin Energy  
23 Corporation, those should be dismissed.

24 EXAMINER STOGNER: Both cases, 13,015 and 13,016,  
25 are to be dismissed?

1 MR. FELDEWERT: Yes, sir.

2 EXAMINER STOGNER: Cases 13,015 and 13,016, are  
3 hereby dismissed.

4 Are there any other continuances or dismissals  
5 from the docket today?

6 Okay.


