APPLICATION OF TRILOGY OPERATING, INC. FOR COMPULSORY POOLING, LEA COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on March 13, 2003, at Santa Fe, New Mexico, before Examiner David K. Brooks.

NOW, on this 7th day of April, 2003, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.
- (2) Trilogy Operating, Inc., ("Applicant"), seeks an order pooling all uncommitted mineral interests from the surface to the base of the Silurian formation underlying the NW/4 SE/4 of Section 11, Township 19 South, Range 38 East, NMPM, Lea County, New Mexico, in the following manner:

The NW/4 SE/4, forming a standard 40-acre oil spacing and proration unit (the "Unit") for all formations or pools spaced on 40 acres within this vertical extent, which presently include but are not necessarily limited to the Undesignated Hobbs-Grayburg-San Andres and Undesignated Nadine-Drinkard-Abo Pools.

- (3) The above-described unit ("the Unit") is to be dedicated to Applicant's proposed Selman Well No. 1 to be drilled at a standard oil well location 2310 from the South line and 2170 from the East line (Unit J) of Section 11, Township 19 South, Range 38 East, NMPM, Lea County, New Mexico.
- (4) Two or more separately owned tracts are embraced within the Unit, and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.

- (5) Applicant is acting on behalf of Stevens & Tull Development LTD., in owner of an oil and gas working interest within the Unit. Stevens & Tull Development LTD. has the right to drill, and Applicant on its behalf proposes to drill, Applicant's Selman Woll No. 1 (the "proposed well") to a common source of supply at a standard well location within the NW/4 SE/4 of Section 34.
- (6) There are interest owners in the proposed unit that have not agreed to pool their interests.
- (7) This case was presented by affidavit without live testimony pursuant to Division Rule 1207.A(1)(b).
- (8) According to affidavits offered by Applicant, Applicant has been unable to locate all owners of interests to be pooled, and Applicant is unopposed by those located.
- (9) No one appeared at the hearing in opposition to the Application or otherwise notified the Division of any opposition thereto.
- (10) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons, this application should be approved by pooling all uncommitted interests, whatever they may be, in the oil and gas within the Unit.
- (11) Applicant should be designated the operator of the proposed well and of the Unit.
- (12) Any pooled working interest owner who does not pay its share of estimated well costs should have withheld from production its share of reasonable well costs plus in additional 200% thereof as a reasonable charge for the risk involved in drilling the well.
- (13) Reasonable charges for supervision (combined fixed rates) should be fixed at \$4,750 per month while drilling and \$475 per month while producing, provided that these rates should be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations."

IT IS THEREFORE ORDERED THAT:

(1) Pursuant to the application of Trilogy Operating, Inc., all uncommitted interests, whatever they may be, in the oil and gas from the surface to the base of the Siluri in formation underlying the NW/4 SE/4 of Section 11, Township 19 South, Range 38 East, N.M.P.M., Lea County, New Mexico, are hereby pooled, as follows:

The NW/4 SE/4, forming a standard 40-acre oil spacing and proration unit for all formations or pools spaced on 40 acres

within this vertical extent, which presently include but are not necessarily limited to the Undesignated Hobbs-Grayburg-San Andres and Undesignated Nadine-Drinkard-Abo Pools.

The Unit shall be dedicated to Applicant's Selman Well No. 1, to be drilled at a standard well location 2310 from the South line and 2170 from the East line (Unit J) of Section 11, Township 19 South, Range 38 East, NMPM, Lea County, New Mexico.


- (2) The operator of the Unit shall commence drilling the proposed well on or before July 31, 2003, and shall thereafter continue drilling the well with due diligence to test the Silurian formation.
- (3) In the event the operator does not commence drilling the proposed well on or before July 31, 2003, Ordering Paragraph (1) shall be of no effect, unless the operator obtains a time extension from the Division Director for good cause.
- (4) Should the proposed well not be drilled to completion, or be abandoned, within 120 days after commencement thereof, the operator shall appear before the Division Director and show cause why Ordering Paragraph (1) should not be rescinded.
- (5) Upon final plugging and abandonment of the proposed well, the pooled unit created by this Order shall terminate, unless this order has been amended to authorize further operations.
- (6) Applicant is hereby designated the operator of the proposed well and of the Unit.
- (7) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including unleased mineral interests, who are not parties to an operating agreement governing the Unit.) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of drilling, completing and equipping the proposed well ("well costs").
- (8) Within 30 days from the date the schedule of estimated well costs is furnished, any pooled working interest owner shall have the right to pay its share of estimated well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges. Pooled working interest owners who elect not to pay their share of estimated wells costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."

- (9) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the proposed well. If no objection to the actual well costs is received by the Division, and the Division has not objected with n 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within the 45-day perio i, the Division will determine reasonable well costs after public notice and hearing.
- (10) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of estimated costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the estimated well costs it has paid exceed its share of reasonable well costs.
- (11) The operator is hereby authorized to withhold the following costs and charges from production:
 - (a) the proportionate share of reasonable well costs attributable to each non-consenting working interest owner; and
 - (b) as a charge for the risk involved in drilling the well, 200% of the above costs.
- (12) The operator shall distribute the costs and charges withheld from productio 1, proportionately, to the parties who advanced the well costs.
- (13) Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$4,750 per month while drilling and \$475 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations." The operator is authorized to withhold fron production the proportionate share of both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to pooled working interest owners.
- (14) Except as provided in Ordering Paragraphs (11) and (13) above, all proceeds from production from the well that are not disbursed for any reason shall be placed in escrow in Lea County, New Mexico, to be paid to the true owner thereof upon demand and proof of ownership. The operator shall notify the Division of the name and address of the escrow agent within 30 days from the date of first deposit with the escrow agent.
- (15) Any unleased mineral interest shall be considered a seven-eighths (7/3) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs ard charges under this order. Any well costs or charges that are to be paid out of production shall

be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.

- (16) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this order, this order shall thereafter be of no further effect.
- (17) The operator of the well and Unit shall notify the Division in writing of the subsequent voluntary agreement of all parties subject to the forced pooling provisions of this order.
- (18) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
