2 11:35 a.m.:

3 EXAMINER BROOKS: At this time we'll call Case
4 Number 13,024, Application of Trilogy Operating, Inc., for
5 compulsory pooling, Lea County, New Mexico.

6 Call for appearances.

7 MR. OWEN: Paul R. Owen of the Santa Fe law firm
8 of Montgomery and Andrews, appearing on behalf of
9 Applicant, Trilogy Operating, Inc.

10 EXAMINER BROOKS: Other appearances?

11 And this is being presented on certificate, so
12 you do not have any witnesses; is that correct?

13 MR. OWEN: That is correct, Mr. Examiner, this
14 case is being presented in accordance with Rule
15 107.A.(1).(b).

16 EXAMINER BROOKS: Okay, you may proceed.

17 MR. OWEN: Mr. Examiner, Trilogy has proposed a
18 well and has satisfied the requirements of Rule
19 107.A.(1).(b). Certain of the interest owners in the
20 subject acreage have been unlocatable.

21 An affidavit certifying all of the facts and all
22 of the requirements of Rule 107.A.(1).(b) was attached as
23 Exhibit B to the Application which was filed on February
24 18th, 2003. That affidavit contains specific statements
25 satisfying all of the requirements in addition to

1 supporting documentation. I move at this time that the
2 Division accept that exhibit as Exhibit B to this hearing.

3 In addition, there was one party that was
4 represented. It is a trust that has an address -- I
5 believe it is Wells Fargo Bank -- and we did provide notice
6 of this hearing by certified mail, return receipt
7 requested, within the time requirements as required by the
8 OCD. I will submit an affidavit of notice immediately
9 following the hearing. I did not prepare that before the
10 hearing.

11 With those things being said, the Application
12 appears to be complete, and we request the Division take
13 the Application under advisement.

14 EXAMINER BROOKS: And the notice, is that this
15 Snyder-Flood Trust?

16 MR. OWEN: That is correct.

17 EXAMINER BROOKS: And the others you have no
18 address for?

19 MR. OWEN: That is correct. Within the
20 affidavit, which was attached as Exhibit A, the Applicant
21 details the efforts in which it engaged to locate these
22 people on the third page of the exhibit, under 7.(iii).

23 EXAMINER BROOKS: Okay. Now, except for these
24 interests that are listed in item 4 on the chronology, has
25 everyone else joined?

1 MR. OWEN: That is correct.

2 EXAMINER BROOKS: Okay. Anything?

3 EXAMINER STOGNER: I have no questions.

4 EXAMINER BROOKS: Very good, Case Number 13,024
5 will be taken under advisement.

6 MR. OWEN: Thank you, Mr. Examiner.
