

3 THE STATE OF NEW MEXICO TO THE DISTRICT COURT sitting  
4 within and for the County of Lea, GREETING:

5 WHEREAS, in a certain cause lately pending before you,  
6 numbered 16213 (consolidated with 16214, 16215, 16217, 16218,  
7 16219 and 16220) on your Civil docket, wherein Continental Oil  
8 Company, et al were Petitioners, and Oil Conservation Commission,  
9 et al were Respondents, by your consideration in that behalf  
10 judgment was entered against said Petitioners; and

11 WHEREAS, said cause and judgment were afterwards  
12 brought into our Supreme Court for review by Petitioners by  
13 appeal and by Respondent Oil Conservation Commission by cross-  
14 appeal, whereupon such proceedings were had that on May 16,  
15 1962, an opinion was handed down and the Judgment of said Supreme  
16 Court was entered reversing your judgment aforesaid, and remanding  
17 said cause to you;

18 NOW, THEREFORE, this cause is hereby remanded to you  
19 with directions to set aside the judgment appealed from and  
20 enter an order sustaining appellants' appeal and declaring the  
21 orders of the Commission No. R-1092-C and No. R-1092-A as in-  
22 valid and void.
