
TO: ADDRESSEE LIST ATTACHED:

Pursuant to discussions among Mr. Cooley, Mr. Campbell, Mr. Kellahin and myself, I called Judge Brand to arrange for a pre-trial conference in the above cases. It was realized that the date selected by the Court would undoubtedly conflict with engagements of some of the attorneys involved in the case, but due to the large number of attorneys involved, that situation would exist regardless of the date selected. The first available date, other than an immediate setting, was requested, and the Court has set Monday, August 4, 1958, at 9:00 A. M. in the District Court House at Lovington, New Mexico, for the hearing of pre-trial conferences in all of the above cases.

It is our understanding that the Commission has prepared a Motion which it will file within the next week setting forth the matters as to which it desires a pre-trial conference and order. As Judge Brand requested that all parties submit an agenda or motion covering the matters which the parties desire to be considered at the pre-trial conference, the Petitioners will, within a week after the filing of the Commission's Motion, file a request for any additional matters which they desire to be heard at the pre-trial conference. It is suggested that the remaining respondents could do likewise. By this procedure all parties should be on notice at least 30 days prior to the hearing as to the matters which any party is going to raise at the hearing.

Judge Brand did not indicate whether he would send an additional notice of the hearing after the filing of the Commission's Motion for the pre-trial conferences, but he did direct me to notify all parties that there would be a pre-trial conference on each of the above cases to be held on August 4, 1958, at 9:00 A. M. in the District Court House at Lovington, New Mexico.
