MENT FOR PRORATION PURPOSES AND FOR  
TWO UNORTHODOX WELL LOCATIONS THEREON.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 10:00 o'clock A.M. on September 17, 1947, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico hereinafter referred to as the "Commission".

NOW, on this 6th day of October, 1947, the Commission having before it for consideration the testimony adduced at the hearing of said case and being fully advised in the premises;

FINDS:

1. That due public notice having been given, jurisdiction of said case is lodged in the Commission.
2. That the  $E\frac{1}{2}$  of the  $NE\frac{1}{4}$  of Section 33, Township 16 South, Range 31 East, N.M.P.M. is Federal acreage and the unitization thereof bearing the approval of the Commissioner of Public Lands of New Mexico is acceptable to the Commission;
3. That by reason of sub-surface conditions obtaining in the Square Lake Field, it is questionable whether or not one well to the 40-acre unit permits maximum drainage;
4. That additional and unorthodox locations neither interfering with the rights of others nor disturbing the unit allowable in the Square Lake Pool are not objectionable to the Commission.

IT IS THEREFORE ORDERED:

- a. That the Johnson 56 Unit Agreement covering the  $E\frac{1}{2}$  of the  $NE\frac{1}{4}$  of Section 33, Township 16 South, Range 31 East, N.M.P.M. in the Square Lake Pool, Eddy County, New Mexico, be and the same is hereby approved for proration purposes;
- b. That an unorthodox location for a well to be located 330 feet from the east line and 1270 feet from the north line of Section 33, Township 16 South, Range 31 East, be, and the same is hereby approved, and in like manner an unorthodox location is approved for a well to be located 990 feet from the east line and 1370 feet from the north line of said Section 33; provided, however, with respect to each location that in case production is had from either or both such wells, no such production and the production from existing wells, shall exceed the unit allowable for the pool or shall production from any well on the unit be produced in excess of the allowable for a single well.
