ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. October 15, 1952, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this *20<sup>th</sup>* day of *October*, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the South Blanco-Pictured Cliffs Pool, San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 27 North, Range 7 West, NMPM  
All of Section 32

(3) That the Blanco-Mesaverde Pool, San Juan County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 31 North, Range 10 West, NMPM  
All of Sections 13 - 16, incl.

Township 31 North, Range 9 West, NMPM  
All of Section 18

Township 28 North, Range 9 West, NMPM  
All of Sections 28 and 33

(4) That the boundaries of the Fulcher-Kutz - Pictured Cliffs Pool, San Juan County, New Mexico, be, and the same hereby are extended to include:

Township 27 North, Range 9 West, NMPM  
All Sections 1 - 5, incl.;  
All Sections 9 - 16, incl.;  
All Sections 21 - 28, incl.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and the same hereby is approved, as follows:

(1) That the boundaries of the South Blanco-Pictured Cliffs Pool, San Juan and Rio Arriba Counties, New Mexico, be, and the same hereby are extended to include:

Township 27 North, Range 7 West, NMPM  
All of Section 32

(2) That the boundaries of the Blanco-Mesaverde Pool, San Juan County, New Mexico, be, and the same hereby are extended to include:

Township 31 North, Range 10 West, NMPM  
All of Sections 13 - 16, incl.

Township 31 North, Range 9 West, NMPM  
All Section 18

Township 28 North, Range 9 West, NMPM  
All of Sections 28 and 33

(3) That the Fulcher-Kutz - Pictured Cliffs Pool, San Juan County, New Mexico, as heretofore classified, defined and described, should be extended to include:

Township 27 North, Range 9 West, NMPM  
All of Sections 1 through 5, incl.;  
All of Sections 9 through 16, incl.;  
All of Sections 21 through 28, incl.

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
