Nomenclature case for southeastern New Mexico (Lea County and Eddy County):

Case No. 438

- Extension of West Dollarhide-Devonian Pool to include SE/4 Section 30 and E/2 Section 31 in Twp. 24 S, Rge 38E; and also the NE/4 Section 6 in Twp. 25 S, Rge. 38E.
- (b) Creation of new oil pool, the Moore-Pennsylvanian, for Pennsylvanian production, to include all Sections 23, 24, 25 and 26 in Twp. 11 S, Rge. 32 E.
- (c) Creation of new oil pool, the Dark Canyon Pool, for Deleware production, to include S/2 Section 22 in Twp. 23 S, Rge. 26 E.
- (d) Creation of new oil pool, the Lazy J Pool, for Pennsylvanian production, to include Section 27, Twp. 13S, Rge. 33 E.
