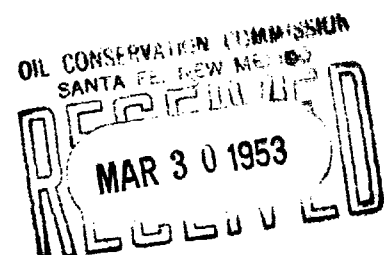

STANLEY JOHN STANLEY,

having been first duly sworn, testified as follows:

DIRECT EXAMINATION

By MR. WHITE:

Q State your full name and position for the record, please.

A Mr. Stanley John Stanley, oil and gas engineer for the  
Oil Conservation Commission, New Mexico.

Q In your capacity as engineer for the Oil Conservation  
Commission have you had occasion to make a study of the proposed  
extensions and deletions as advertised in Case No. 524?

A I have.

Q Will you give a report of your study together with your conclusions and recommendations?

A I recommend that all extensions and deletions be made as advertised and for the record I would like to submit a plat describing the extensions and deletions of the existing pools in support of my recommendations.

Q It is your recommendation that the extensions and deletions be made as advertised?

A Yes.
