ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 16, 1953, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this ^{ed} 23 day of June, 1953, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Denton-Wolfcamp Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 14 South, Range 37 East, NMPM
S/2 Section 26;
N/2 Section 35

(3) That the Gladiola-Wolfcamp Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 12 South, Range 38 East, NMPM
SW/4 Section 18;
NW/4 Section 19

(4) That the Hare Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 21 South, Range 37 East, NMPM
Lots 9, 10, 15 and 16 of Section 2

(5) That the South Leonard Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 26 South, Range 37 East, NMPM
SE/4 Section 14

(6) That the Lovington-Paddock Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 16 South, Range 37 East, NMPM
All Section 32, W/2 Section 33

(7) That the Skaggs Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 20 South, Range 37 East, NMPM
E/2 Section 11;
E/2 Section 14

(8) That the North Warren-McKee Pool boundary in Lea County, New Mexico, as heretofore classified, defined and described, should be extended to include therein:

Township 20 South, Range 38 East, NMPM
W/2 Section 7

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and the same hereby is approved as follows:

(1) That the boundaries of the Denton-Wolfcamp Pool, Lea County, New Mexico, be and the same hereby are extended to include:

Township 14 South, Range 37 East, NMPM
S/2 Section 26;
N/2 Section 35

(2) That the boundaries of the Gladiola-Wolfcamp Pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Township 12 South, Range 38 East, NMPM
SW/4 Section 18;
NW/4 Section 19

(3) That the boundaries of the Hare Pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Township 21 South, Range 37 East, NMPM
Lots 9, 10, 15 and 16 of Section 2

(4) That the boundaries of the South Leonard Pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Township 26 South, Range 37 East, NMPM
SE/4 Section 14

(5) That the boundaries of the Lovington-Paddock Pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Township 16 South, Range 37 East, NMPM
All Section 32, W/2 Section 33

(6) That the boundaries of the Skaggs Pool, Lea County, New Mexico, be, and the same hereby are extended to include:

Township 20 South, Range 37 East, NMPM
E/2 Section 11;
E/2 Section 14

(7) That the boundaries of the North Warren-McKee Pool, Lea County, New Mexico, be, and the same hereby are extended to include:


