CRDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on July 16, 1953, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 27 day of July, 1953, the Commission, a quorum being present, having considered the testimony adduced and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the application of the Oil Conservation Commission upon its own motion for the extension of boundaries of existing pools in Lea and Eddy Counties, New Mexico, as advertised, should be so ordered.

IT IS THEREFORE CRDERED:

(a) That the boundary of the classified and defined East Caprock-Devonian Pool in Lea County, New Mexico, be, and the same hereby is extended to include therein as part of said pool:

Twp. 12 South, Rge. 32 East, NMPM N/2 Section 2

(b) That the boundary of the classified and defined Crossroads-Pennsylvanian Pool in Lea County, New Mexico, be, and the same hereby is extended to include therein as a part of said pool:

Twp. 9 South, Rge. 36 East, NMPM E/2 Section 19

(c) That the boundary of the classified and defined Dollarhide-Drinkard Pool in Lea County, New Mexico, be, and the same hereby is extended to include therein as a part of said pool:

Twp. 25 South, Rge. 38 East, NMPM N/2 Sect. 5; that portion of the N/2 of Sect. 4 which lies within the State of New Mexico

(d) That the boundary of the classified and defined Dollarhide-Queen Pool in Lea County, New Mexico, be, and the same hereby is extended to include therein as a part of said pool:

Twp. 24 South, Rge. 38 East, NMPM S/2 Section 30

Pool (e) That the boundary of the classified and defined Eidson-Pennsylvanian in Lea County, New Mexico, be, and the same hereby is extended to include therein as a part of said pool:

Twp 16 South, Rge. 35 East, NMPM
SE/4 Section 7; SW/4 Section 8;
NW/4 Section 17

(f) That the boundary of the classified and defined East Hobbs-San Andres Pool in Lea County, New Mexico, be, and the same hereby is extended to include therein as a part of said pool:

Twp. 18 South, Rge. 39 East, NMPM All Section 30; N/2 Section 31

(g) That the boundary of the classified and defined Monument-Blinebry Pool in Lea County, New Mexico, be, and the same hereby is extended to include therein as a part of said pool:

Twp. 20 South, Rge. 37 East, NMPM NE/4 Section 7; NW/4 Section 8

(h) That the boundary of the classified and defined Empire Pool in Eddy County, New Mexico, be, and the same hereby is extended to include therein as a part of said pool:

Twp. 17 South, Rge. 28 East, NMPM SE/4 Section 19; E/2 Section 30

IT IS FURTHER ORDERED That the nomenclature plats in the Commission offices be changed in accordance herewith.
