(MR. CAMPBELL: If the Commissioner please, Jack Campbell, representing Gulf Oil Corporation. It is my understanding Gulf is the owner, operator, and purchaser of the only gas well in the Amanda Pool. Since the Commission made the finding that pro ration is necessary, we would like to have the record show that the statement of Gulf in Case No. 588 be incorporated in Case No. 582--I mean, Case 582 be incorporated in Case 588.

We have no allocation formula to submit.

MR. SPURRIER: Is there objection to counsel's motion? If not, his remarks will be incorporated in this case as they were in Case No. 582.

Does anyone have testimony to offer in Case 588? Does anyone have a comment in this case? Counsel Foster.

MR. FOSTER: We have no interest in this pool.

MR. SPURRIER: If there is nothing further, these cases are completed until the Commission can peruse the record, and we will stand adjourned today, and meet here tomorrow for Cases 583, the Langmat, 589, the Justis, and 590, the Byers-Queen.
