COMMISSIONER WALKER: The next case is 604.

the witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

By MR. GRAHAM:

Q Will you state your name and official position, please?

A Elvis A. Utz, Engineer, Oil Conservation Commission.

Q In your capacity as engineer for the Commission, have you had occasion to examine the Case 604 in the matter of the corrections of existing pools in San Juan, Rio Riba County as advertised?

A Yes, I have.

Q Do you have any recommendations?

A Yes, I have. I recommend that the pools Blanco, Mesa-verde Pool, the south Blanco - Tocito and the south Blanco - Dakota and the south Blanco - Pictured Cliffs Pools be extended as advertised with one exception. The Blanco - Mesaverde Pool, it was recommended in 29 North, 5 West to include sections one through 16 and nine through 33, this should include 19, ~~of~~ one through 16 and 19 through 36.

Q As advertised?

A As advertised. It is not advertised that way. It should include that correction from 33 to 36. 29 North, 5 West. It should include 34, 35, 36. It may be, however, we will have to re advertise that three sections. Other than that, I recommend that the extensions be made as advertised and I submit an exhibit which lists all those extensions and the wells which support those extensions.

Q No further statement to be made?

A No, I have nothing further.

COMMISSIONER WALKER: Any questions of the witness? If not, the witness may be excused. The case will be taken under advisement. If no further comments, the Oil Commission meeting will be adjourned.
