MR. MACY: We have a letter from Amon G. Carter, pertaining to this application, and I will put it in the record. Addressed to the Oil Conservation Commission, State of New Mexico, Santa Fe, New Mexico, "Gentlemen: Please refer to our application of October 31st, 1953 for permission to dually complete the above well in the Upper Devonian Horizon and the McKee Horizon.

Please be advised that after the filing of above application we made sufficient preliminary tests of the Upper Devonian Section to determine that the volume of gas evidenced by the first two tests could not be maintained. In fact the gas volume had declined to such extent that it did not appear commercially feasible to undertake to produce gas from this horizon.

We have therefore squeezed off the perforations in the 7 inch casing from 7,150 to 7,196 and are now in process of completing this well as a single producer from the McKee Horizon. Complete information will be filed on the well in the usual manner as soon as we have secured a potential test on the McKee Section. Yours very truly, Amon G. Carter".
