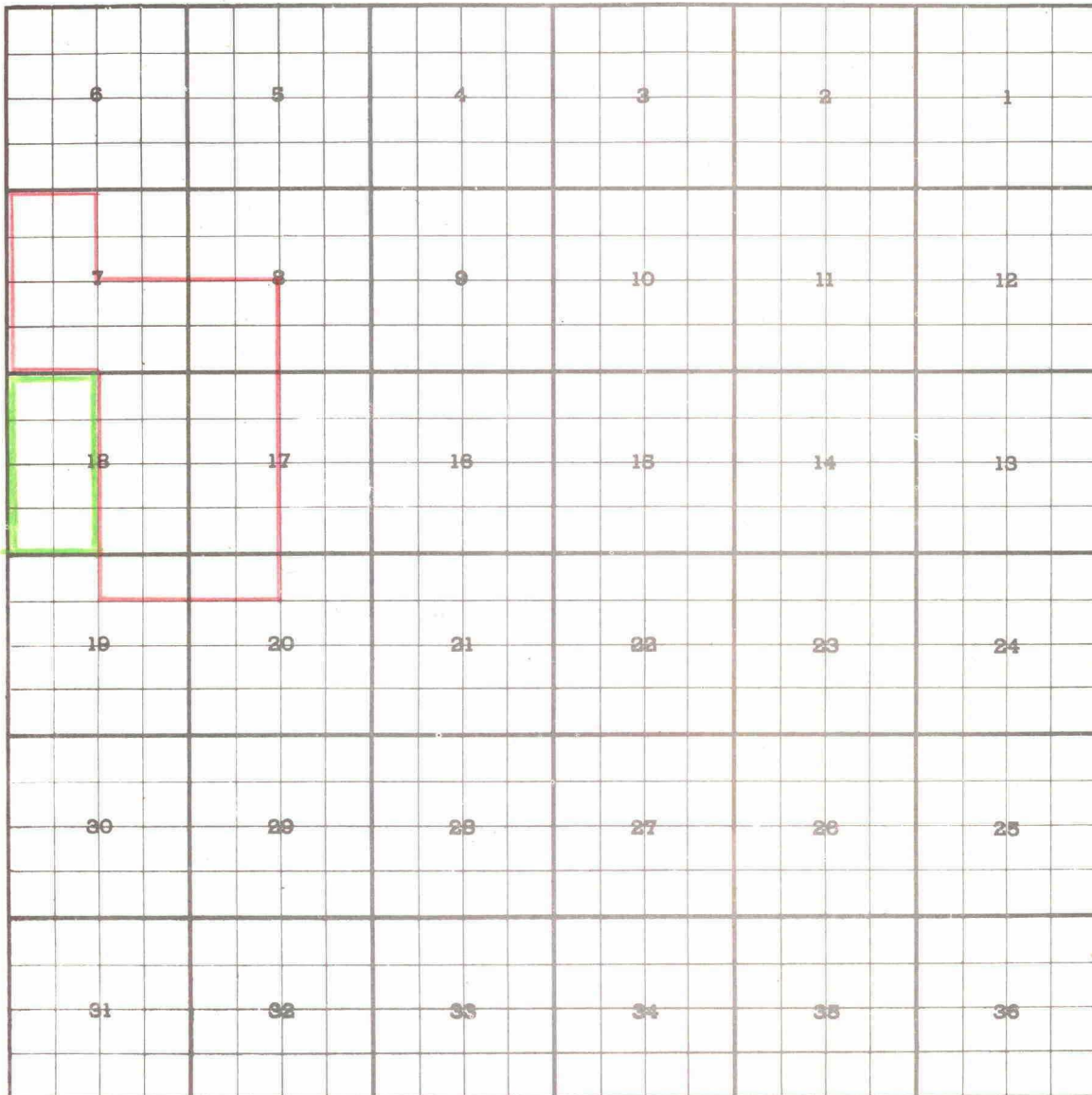

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on February 17, 1954, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this *26<sup>th</sup>* day of *February*, 1954, the Commission, a quorum being present, having considered the testimony adduced and exhibits received at said hearing,

FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Hackberry-Yates Oil Pool in Eddy County and the House-Tubb Gas Pool in Lea County, New Mexico, should be created as advertised.

(3) That the East Hobbs-San Andres and the North Warren-McKee Oil Pools in Lea County, New Mexico, should be extended to conform with testimony presented at the hearing.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be and the same hereby is approved, as follows:

(1) That the Hackberry-Yates Pool in Eddy County, New Mexico, be created for oil production from the Yates formation, and described as:

Township 19 South, Range 30 East, NMPM  
SE/4 Section 36

(Creation of this pool is based upon Claud E. Aikman's Stanolind State No. 1 discovery well, NW/4 SE/4 36-19S-30E, NMPM, Eddy County, producing from the Yates formation from the open-hole section below the casing at 2047 feet.)

(2) That the House-Tubb Gas Pool be created in Lea County for production of gas from the Tubb formation, and described as follows:

Township 20 South, Range 38 East, NMPM  
Sections 11 and 12, all

(Creation of this pool is based upon Stanolind Oil & Gas Co.'s discovery well, T. W. Arnold 'A' No. 1, SE/4 NW/4 11-20S-38E, NMPM, Lea County, producing from the Tubb formation with top of perforations at 6760 feet.)

(3) That the East Hobbs-San Andres Oil Pool in Lea County, New Mexico, as previously classified, defined and described, should be extended to include:

Township 18 South, Range 38 East, NMPM  
SE/4 Section 25

(4) That the North Warren-McKee Oil Pool in Lea County, New Mexico, as previously classified, defined and described, should be extended to include:

Township 20 South, Range 38 East, NMPM  
W/2 Section 18

DONE at Santa Fe, New Mexico, on the day and year hereinabove designated.
