DIRECT EXAMINATION

By MR. YOST:

- Q State your name, please.
- A Elvis A. Utz, Engineer with Oil Conservation Commission.
- Q You are acquainted with the subject matter of Case 671

which provide for the creation and extension in San Juan and Rio Arriba Counties?

A Yes, I am.

Q Will you please give the Commission the benefit of your observation and any recommendation you might care to make in that matter?

A I recommend that the creation of the East Blanco-Pictured Cliff Pool for Pictured Cliff production as set forth in part (a) of the advertisement be created. I also recommend the extension of Blanco - Mesaverde Pool as set forth in Section (b). The extension of South Blanco-Pictured Cliff as set forth in (c). The extensions of Aztec-Pictured Cliff Pool as set forth in (d), and the extension of South Blanco-Tocito Pool as set forth in (e). In support of my testimony I would like to present an Exhibit which states the one creation, and the other extensions together with the locations of the producing wells which support it. That is all I have.

MR. SPURRIER: Any questions of the witness?

MR. YOST: We will offer Exhibit One into evidence.

MR. SPURRIER: Is there objection to the introduction of this Exhibit? If not, the Exhibit will be received. Any comments in this case? If not, the case is taken under advisement and the hearing is adjourned.

THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER FOR THE CREATION OF NEW POOLS AND EXTENSION OF EXISTING POOLS IN SAN JUAN AND RIO ARRIBA COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 17, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 3/ day of March, 1954, the Commission, a quorum being present, having considered the testimony presented in the case, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the East Blanco-Pictured Cliffs Pool in Rio Arriba County, New Mexico, should be created as advertised.
- (3) That extensions as advertised should be approved for the Blanco-Mesaverde Pool, the South Blanco-Pictured Cliffs Pool, the Aztec-Pictured Cliffs Pool and the South Blanco-Tocito Pool, as previously created and described by Commission orders.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission be, and it hereby is approved as follows:

(a) That a new pool be created in Rio Arriba County, New Mexico, designated as the East Blanco-Pictured Cliffs Pool for production of gas from the Pictured Cliffs formation, and described as follows:
