APPROVAL OF AN EXCEPTION PURSUANT
TO RULE 7 (a) OF ORDER NO. R-370-A IN
ESTABLISHMENT OF AN UNORTHODOX GAS
PRORATION UNIT OF 40 CONTIGUOUS ACRES
CONSISTING OF NE/4 SE/4 OF SECTION 29,
TOWNSHIP 19 SOUTH, RANGE 37 EAST, NMPM.,
LEA COUNTY, NEW MEXICO IN THE EUMONT
GAS POOL.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a. m., on June 16, 1954, at Santa Fe, New Mexico, before the Oil Conservation Commission, herein-after referred to as the "Commission".

NOW, on this 7th day of July, 1954, the Commission, a quorum being present, having considered the records and testimony adduced, and being fully advised in the premises;

FINDS:

(1) That due notice of the time and place of hearing and the purpose thereof having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That pursuant to provisions of Rule 7 (a) of Order No. R-370-A, the Commission has power and authority to permit the formation of a gas proration unit consisting of other than a legal quarter section after notice and hearing by the Commission.

(3) That applicant, Shell Oil Company, is the owner of an oil and gas lease in Lea County, New Mexico the land consisting of other than a legal quarter section, and described as follows, to-wit:

TOWNSHIP 19 SOUTH, RANGE 37 EAST, NMPM.
NE/4 SE/4 of Section 29

containing 40 acres, more or less.

(4) That applicant, Shell Oil Company, has a producing well on the aforesaid lease known as State "F", No. 1, located 1980' from the South line and 660' from the East line of Section 29, Township 19 South, Range 37 East.

(5) That the aforesaid well is located within the limits of the pool heretofore delineated and designated as the Eumont Gas Pool.

(6) That efforts are being made to communitize the above described 40 acres with other lease owners in the SE/4 of Section 29 and pending the outcome of such negotiations the aforementioned unorthodox unit should be approved.

(7) That unless a proration unit consisting of applicant's aforesaid acreage is permitted, applicant will be deprived of the opportunity to recover its just and equitable share of the natural gas in the Eumont Gas Pool.

(8) That creation of a proration unit consisting of the aforesaid acreage will not cause but will prevent waste and will protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the application of Shell Oil Company for approval of an unorthodox proration unit consisting of the following described acreage

TOWNSHIP 19 SOUTH, RANGE 37 EAST, NMPM.
NE/4 SE/4 of Section 29

be and the same is hereby approved, and a proration unit consisting of aforesaid acreage is hereby created.


(2) That applicant's well, State "F", No. 1, located in the NE/4 SE/4 of Section 29, Township 19 South, Range 37 East, NMPM, shall be granted an allowable in the proportion that the above described 40 acre unit bears to the standard or orthodox proration unit for said pool, all until further order of the Commission.
