On December 31, 1954, by virtue of the provisions of Administrative Order NSP-68, I approved the formation of a non-standard gas proration unit consisting of the following described acreage in the Jalmat Gas Pool:

Section 3, Township 22 South, Range 36 East S/2 and NE/4

Information available to me at this time indicates that I exceeded the authority granted to me by the provisions of Rule 5-b of Order R-520 (Jalmat Pool Rules) due to the fact that the third paragraph of Rule 5-a specifically limits the maximum amount of acreage that may be assigned to a gas well, the amount being governed by the well location.

The formation of a 480-acre non-standard proration unit with your Harry Leonard State "D" lease, Well No. 3, located 1980 feet from the South line and 1980 feet from the West line is contrary to the provisions of this rule.

On February 16, 1955, this Commission will hold hearings directed to you as operator for you to show cause why the acreage assigned your Harry Leonard State "D", Well No. 3, NE/4 SW/4 Section 3, Township 22 South, Range 36 East, NMPM, Jalmat Gas Pool, should not be reduced to 320 acres in accordance with the provisions of Paragraph 3 of Rule 5-a of Order R-520.
