Pursuant to Commission Order No. R-179A, Gulf Coast Western Oil Company, Humble Oil & Refining Company, and Skelly Oil Company initiated a pilot water flood of the Queen Sand underlying Section 34, T-22-S, R-37-E, in the Penrose Skelly Field, Lea County, New Mexico, by the conversion of Skelly's H. O. Sims No. 9 and 10, Humble's N. M. State "H" No. 7, Gulf Coast Western's T. O. May No. 1, and Gulf Coast Western's Humble State "H" No. 1 to water injection wells. Effective November 1, 1955, the cumulative volumes of water injected were 127,223 barrels into Skelly's Sims No. 8, 111,537 barrels into Skelly's Sims No. 9, 115,328 barrels into Humble's N. M. State "H" No. 7, 29,890 barrels into Gulf Coast Western's T. O. May No. 1, and 67,570 barrels into Gulf Coast Western's Humble State "H" No. 1. Current status of the flood area is shown by the attached plat.

A joint hearing is hereby requested by Humble Oil & Refining Company and Gulf Coast Western Oil Company for the intended purpose of securing Commission authority for expanding the existing flood area to the extent of converting the following wells to water injection: Humble N. M. State "H" No. 2 and "H" No. 3, and Gulf Coast Western's F. S. Glier No. 2 and No. 3. Waivers from the offset operators are being requested.

We would appreciate this matter being set for a hearing at an early date before the Commission in Santa Fe, New Mexico, or before an examiner in Hobbs, New Mexico.


