TRANSCRIPT OF HEARING

MR. MACEY: The next case on the docket is Case Number 1035.

E L V I S   A .   U T Z

called as a witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

By MR. KITTS:

Q State your name and position.

A Elvis A. Utz, Engineer, Oil Conservation Commission.

Q Are you familiar with Case 1035?

A Yes, I am.

Q Mr. Utz, in 1035, as advertised, there are certain extensions in Paragraphs (a) through (e), inclusive. First, on Paragraph (a), state what the recommendation is and the basis for it.

A I recommend the Ballard-Pictured Cliffs Pool be extended as advertised, on the basis of seven completed wells capable of producing in the Ballard - Pictured Cliffs Gas Pool.

Q You have those wells noted on your exhibit?

A Yes, I have, and I will submit this as an exhibit.

Q To Paragraph (b)?

A I recommend that Paragraph (b) be extended as advertised on the basis of five wells completed in the South Blanco-Pictured Cliffs Gas Pool capable of producing.

Q (c), what is your recommendation?

A (c) I likewise recommend that the Fulcher Kutz-Pictured Cliffs Pool be extended on the basis of one well capable of producing in the Fulcher Kutz-Pictured Cliffs Pool.

Q Paragraph (d)?

A I recommend that the West Kutz-Pictured Cliffs Gas Pool be extended as advertised on the basis of one well completed, and capable of producing in this pool.

Q Paragraph (e)?

A I recommend that the Canyon Largo-Pictured Cliffs Pool be extended on the basis of two wells capable of producing in the field.

Q Mr. Utz, have you prepared an exhibit stating your recommendation and basis therefore?

A Yes, I have.

MR. KITTS: We offer in evidence Commission Staff's Exhibit 1, Case 1035.

MR. MACEY: Is there any objection? If not the exhibit will so be entered. Is there any question of the witness?

MR. NUTTER: All those were as advertised; is that right?

A That is correct.


MR. MACEY: Anyone else? If not, we will take the case under advisement, and the hearing is adjourned.
