SAID WELLS, THE JICARILLA 5-E
WELL TO BE LOCATED 1650 FEET FROM
THE NORTH LINE AND 1585 FEET FROM
THE WEST LINE OF SECTION 16,
TOWNSHIP 26 NORTH, RANGE 4 WEST,
AND APPLICANT'S JICARILLA 3-D WELL
TO BE LOCATED 1650 FEET FROM THE
SOUTH LINE AND 1090 FEET FROM THE
EAST LINE OF SECTION 32, TOWNSHIP 26
NORTH, RANGE 3 WEST, NMPM, ALL IN
RIO ARriba COUNTY, NEW MEXICO.**

ORDER OF THE COMMISSION

BY THE COMMISSION:

**This cause came on for hearing at 9 o'clock a.m. on
May 23, 1956, at Hobbs, New Mexico, before Warren W. Mankin,
Examiner duly appointed by the Oil Conservation Commission of New
Mexico in accordance with Rule 1214 of the Rules and Regulations
of the New Mexico Oil Conservation Commission.**

**NOW, on this 13th day of June 1956, the Commission,
a quorum being present, having considered the application, the
evidence adduced, the recommendations of the Examiner, Warren W.
Mankin, and being fully advised in the premises,**

FINDS:

**(1) That due notice of the time and place of hearing
and the purpose thereof having been given as required by law, the
Commission has jurisdiction of this case and the subject matter
thereof.**

**(2) That sufficient evidence was adduced to justify
granting of the two subject unorthodox locations.**

**(3) That there were no objections entered at the
hearing to the granting of this application.**

IT IS THEREFORE ORDERED:

That the application of Southern Union Gas Company for an order granting an approval of two unorthodox locations for applicant's proposed Jicarilla 3-D Well to be located 1650 feet from the South line and 1090 feet from the East line of Section 32, Township 26 North, Range 3 West, and its Jicarilla 5-E Well to be located 1650 feet from the North line and 1585 feet from the West line of Section 16, Township 26 North, Range 4 West, Tapacito-Pictured Cliffs Gas Pool, Rio Arriba County, New Mexico, be and the same hereby is granted.
