Be: Application for Approval of a 120-acre Non-Standard Gas Proration Unit to be Assigned Gulf Oil Corporation's Bell-Ramsay "A" Well No. 5 in the Eumont Gas Pool, Lea County, New Mexico

Gentlemen:

Gulf Oil Corporation respectfully submits application for a 120-acre non-standard gas proration unit comprising the SW/4 of the SW/4 of Section 4 and the W/2 of the NW/4 of Section 9, T-21-S, R-36-E, Lea County, New Mexico, to be assigned Gulf's Bell-Ramsay "A" Well No. 5 recently recompleted as a gas well in the Queen formation of the Eumont Gas Pool. It is requested that the Commission set this matter for hearing at an early date.

The following facts are offered in support of this application:

- (1) Gulf Oil Corporation is the owner and operator of the Bell-Ramsay "A" Lease, as shown on the attached plat, which consists of the W/2 of the W/2 of Section 9 and the W/2 of the W/2 of Section 4, T-21-S, R-36-E.
- (2) The proposed unit well, Gulf's Bell-Ramsay "A" No. 5, located 660 feet from the west line and 660 feet from the south line of Section 4, T-21-S, R-36-E, Lea County, New Mexico, was originally completed October 15, 1935, in the upper San Andres formation of the Eunice Oil Pool. On April 28, 1956, this well was plugged back to 3672 feet and recompleted in the Queen formation of the Eumont Gas Pool through casing perforations from 3350-3380', 3395-3455', and 3475-3495', which is within the vertical limits of the Eumont Gas Pool as defined in Order No. R-520.

- (3) Gulf Oil Corporation proposes to assign the SW/4 of the SW/4 of Section 4 and the W/2 of the NW/4 of Section 9, a portion of our Bell-Ramsay "A" Lease, to the above described unit well as a non-standard 120-acre gas proration unit in exception to Rule 5 of the New Mexico Oil Conservation Commission Order No. R-520.
- (4) No other Eumont gas well is completed on the 120-acre unit proposed under this application.
