Gentlemen:

Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (b) of the Special Rules and Regulations for the Eumont Gas Pool in Order No. R-520 for an enlargement from 80 acres to 160 acres of the non-standard gas proration unit presently assigned its A. M. Lockhart A-18 No. 1 well located 330 feet from South and East lines of Section 18, T21S, R36E, Lea County, New Mexico in the Eumont gas pool.

The unit presently consists of the S/2 SE/4 of Section 18, T21S, R36E, and is proposed to consist of the S/2 S/2 of said Section 18.

In support of this request we should like to point out that the proposed unit conforms with the requirements of said Rule 5 (b) in all respects as follows:

1. Said unit consists of contiguous quarter-quarter sections (and/or lots).
2. Said unit lies wholly within a single governmental section.
3. The entire proposed unit may be reasonably presumed to be productive of gas.
4. The length or width of said unit does not exceed 5,280 feet.
5. Copies of this application have been furnished this date by registered mail to all offset operators and all operators within 1,500 feet of said well, as required by said rule 5 (b).

A plat is attached hereto showing to the best of our knowledge and belief the proposed unit, the location of the well and the offset ownership.


