THE APPLICATION OF STANOLIND OIL AND GAS COMPANY FOR AN ORDER GRANTING PERMISSION TO COMPLETE IN THE HOGBACK-DAKOTA POOL, SAN JUAN COUNTY, NEW MEXICO, WITHOUT THE USE OF PRODUCING TUBING IN EXCEPTION TO BULE 107 (c) OF THE NEW MEXICO OIL COMBERVATION COMMISSION RULES AND REGULATIONS, ITS USG SECTION 19-29-16 WELL NO. 15, LOCATED 1600' FROM THE MORTH LINE AND 2374' FROM THE EAST LINE OF SECTION 19, TOWNSHIP 29 NORTH, RANGE 16 WEST, NMPM, AND ITS PROPOSED USG SECTION 18-29-16 WELL NO. 16 LOCATED 900 FEET FROM THE SOUTH LINE AND 1750 FRET FROM THE EAST LINE OF SECTION 18, TOWNSHIP 29 NORTH, RANGE 16 WEST, SAN JUAN COUNTY, NEW MEXICO.

### ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 10:00 o'clock a.m. on September 6, 1956, at Hobbs, New Mexico, before Warren W. Mankin, Examiner duly appointed by the New Mexico Oil Conservation Commission, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this <u>27<sup>th</sup></u> day of September, 1956, the Commission, a quorum being present, having considered the application, the evidence adduced and the recommendations of the Examiner, Warren W. Mankin, and being fully advised in the premises,

## FINDS:

(1) That due notice having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That applicant proposes to drill two wells in the Hogback-Dakota Pool, said wells to be known as USG Section 19-29-16 Well No. 15, located 1600 feet from the North line and 2374 feet from the East line of Section 19, and USG Section 18-29-16 Well No. 16 located 900 feet from the South line and 1750 feet from the East line of Section 18, all in Township 29 North, Range 16 West, NMPM, San Juan County, New Mexico. -2-Order No. R-886

(3) That all oil production in the Hogback-Dakota Pool is operated entirely by the applicant.

(4) That applicant proposes to utilize 3 1/2" tubing as the producing oil string and to complete without the use of the producing tubing string for the above-mentioned wells.

(5) That equipment to be used is adequate to properly flow said wells to depletion without the use of tubing.

### IT IS THEREFORE ORDERED:

That the application of Stanolind Oil and Gas Company for an order granting permission to complete in the Hogback-Dakota Pool, San Juan County, New Mexico, by utilizing 3 1/2" tubing as the producing eil string and without the use of producing tubing string for its USG Section 19-29-16 Well No. 15, located 1600 feet from the North line and 2374 feet from the East line of Section 19, and its proposed USG Section 18-29-16 Well No. 16 located 900 feet from the South line and 1750 feet from the East line of Section 18, all in Township 29 North, Range 16 West, NMPM, San Juan County, New Mexico, be and the same is hereby granted.
