IN THE MATTER OF THE ALFLICATION OF CONTINENTAL OIL COMPANY FOR AUTHORITY TO EFFECT A GAS-GAS DUAL COMPLETION IN THE SULE AND BETMEDEN FORMATIONS IN ITS WALKEN UNIT THE NO. 8 LOCATED 1980 FEET FROM SOUTH AND HAST LIMES OF SECTION 28-T20S-R38E, EMPM, LEA COUNTY, NEW MEXICO, AND FOR FETTISSION TO STORE LIQUIDS PRODUCED FROM THE TWO ZONES IN COMMON TANKAGE.

<u>A P P L I C A T I O N</u>

Comes now applicant, Continental Oil Company, and respectfully petitions the Commission for authority to effect a gas-gas dual completion in the Turb and Elinebry formations in its Jarren Unit well No. 8 and to commingle the liquids produced therefrom, and in support thereof would show:

1. That applicant is operator of the Warren Unit which contains, in addition to other lands, Section 2°-T2OS-R38E, Lea County, New Mexico.

2. That applies nt drilled and completed on March 12, 1950, its Warren Unit Frinkard well No. 8 as an oil well in the Drinkard formation at a location 1980 feet from south and east lines of said Section 28.

3. That production from said well declined to such a rate that it was plugged back and tested in the Tubb and Elinebry formations.

4. That tests in the Tubb and Blinebry formations indicate that both formations will produce gas in commercial cuantities.


5. That the proposed dual completion will be accomplished by utilizing parallel tubing strings and such packers and other equipment as are necessary and adequate to maintain separation of the fluids produced from each of the two producing formations.

- That the dual completion of the said well as proposed is mechanically and economically feasible and is in the interest of conservation of gas.
- 7. That surface equipment will provide means of taking accurate tests of the individual formations and measurement of the production therefrom as required by the Commission.

Wherefore, applicant respectfully prays that this application be set for hearing before the commission's duly appointed examiner at Hobbs, New Mexico, that due notice thereof be given and that upon hearing an order be entered granting applicant authority to effect the dual completion described above, and to commingle the liquids therefrom in common storage tanks.
