AMENDED APPLICATION

Comes now Continental Oil Company, and makes application to
amend the application heretofore filed herein, by adding thereto
the following matter :

Add an additional paragraph, to be numbered 9, following
paragraph 8 on page 2 of the application, as follows:

9. That the well presently being drilled is designated as
applicant's Meyer B 28 "A" Well No. 1, and is located 1980
feet from the North line, and 1980 feet from the East
East line of said Section 28.

Add an additional paragraph, to be numbered 10, as follows:

10. That no part of the acreage comprising the proposed
unit is presently allocated to a gas well in the Eumont Gas Pool,
except that by order No. MSP 295, a non-standard gas proration
unit consisting of the 240 acres above described has been approved
for allocation to said well, contingent upon applicant's filing
an affidavit of communitization. That all of said acreage may be
reasonably presumed to be productive of gas from the Eumont Gas
Pool, and should be allocated to said well in the interests of the
prevention of waste and the protection of correlative rights,
and that the 240 acre unit should be established, as provided by
order No. MSP 295, or that said order be rescinded, and an order
entered by the Commission approving such unit.

That the prayer for relief in said application be amended
to read as follows:

WHEREFORE, applicant respectfully requests that this applica-
tion be set for hearing before the Commission's duly appointed
examiner in Hobbs, New Mexico; that after notice and hearing as
required by law, the Commission enter its order pooling the

rights and interests of all persons having the right to drill for, produce or share in the production of oil or gas, or both of them, from the Eumont Gas Pool underlying the NE/4 and E/2 NW/4, of Section 28, Township 20 South, Range 37 East, Lea County, New Mexico, upon such terms as are just and reasonable, and that a non-standard gas proration unit of 240 acres be approved for allocation to said Meyer E-28 "A" Well No. 1, and for such other and further relief as may be proper.

Except as amended herein, the application is in all respects ratified and confirmed.
