TRANSCRIPT OF PROCEEDINGS

MR. PORTER: Let's proceed with Case No. 1176.

ELVIS UTZ

called as a witness, having first been duly sworn, testified as follows:

DIRECT EXAMINATION

BY: MR. COOLEY:

Q Will you state your name and occupation?

A Elvis A. Utz, engineer for the Oil Conservation Commission.

Q Have you previously testified as an expert witness before this Commission?

A Yes, I have.

Q Mr. Utz, in your capacity as engineer for the Oil Conservation Commission, have you had an opportunity to make a study of the Ballard-Pictured Cliffs Gas Pool?

A Yes, I have, and I recommend that the Ballard-Pictured Cliffs Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q Mr. Utz, have you also made a study of the Aztec-Pictured Cliffs Gas Pool?

A Yes, I have, and I recommend that the Aztec-Pictured Cliffs Pool be extended as advertised on the basis of one well capable of producing in this pool.

Q What are your recommendations with respect to the Otero-Pictured Cliffs Gas Pool?

A I recommend that the Otero-Pictured Cliffs Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q Do you have any recommendation with respect to the Tapicito-Pictured Cliffs Gas Pool?

A Yes, sir, I have. I recommend that Tapicito-Pictured Cliffs Gas Pool be extended as advertised on the basis of three wells completed and capable of producing from this pool.

Q What are your recommendations with respect to the West Kutz-Pictured Cliffs Gas Pool?

A I recommend that the West Kutz-Pictured Cliffs Gas Pool extended as advertised on the basis of one well capable of producing from this pool.

Q Do you have any recommendations regarding the Bisti Lower Gallup Oil Pool?

A Yes, sir, I recommend that the Bisti Lower Gallup Oil

Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q Do you have any further recommendations to present to the Commission?

A No, I have not. However, I have an exhibit.

Q Do you have an exhibit?

A Yes, I have an exhibit that I would like to offer which states this extension, and the wells which they are based on.

MR. PORTER: Mark that Exhibit No. 1 in Case 1176. Is that your only exhibit?

A Yes, sir, it is.

MR. COOLEY: I move the Commission to accept Exhibit No. 1 in Case 1176.

MR. PORTER: Without objection it will be admitted. The case will be taken under advisement and the hearing is adjourned.
