JOHN W. RUNYAN

a witness, of lawful age, having been first duly sworn on oath, testified as follows:

DIRECT EXAMINATION

By MR. GURLEY:

Q Would you state your name and position, please?

A John W. Runyan, geologist, New Mexico Oil Conservation Commission.

Q Have you appeared before this Commission before?

A Yes, sir, I have.

Q Have you, in your capacity as geologist, had an opportunity to study the creation of a new oil pool for San Andres production, to be designated as the West Cave-San Andres Pool?

A Yes, sir, I have. The cause for this creation is the G. Kelly Stout Superior No. 1 located in Unit J, Section 12, Township 17 South, Range 28 East, completed 8/3/55, in the San Andres, the top of the perforation at 2434.

Q What do you recommend?

A I recommend that this pool be created as advertised.

Q Have you, in your official capacity, had the opportunity to study the creation of a new oil pool for Pennsylvanian production to be designated as the Four Lakes-Pennsylvanian Pool?

A Yes, sir.

Q What are your recommendations?

A I recommend that this pool be created as advertised.

Q Have you likewise had an opportunity to study the proposed creation of a new oil pool for Grayburg production, designated as 5

the West Henshaw-Grayburg Pool?

A Yes, sir, I have, and I recommend that it be created as advertised.

Q Have you made a study of the proposed creation of the oil pool for Pennsylvanian production to be designated as the Leamex-Pennsylvanian Pool?

A Yes, sir, I have, and I recommend that it be created as advertised.

Q Have you had an opportunity to study the proposed creation of a new oil pool for Pennsylvanian production, designated as the Milnesand-Pennsylvanian Pool?

A Yes, sir, I have, and I recommend that it be created as advertised.

Q Have you likewise studied the proposed creation of a new oil pool for Grayburg and San Andres production to be designated as the West Square Lake-Grayburg-San Andres Pool?

A Yes, sir, I have, but I recommend that this be dismissed. After further study, we find that we can extend existing pools to take in this area.

Q Have you had an opportunity to study the proposed creation of a new gas pool for Pennsylvanian production, designated as the Welch-Pennsylvanian Gas Pool?

A Yes, sir, I have, and I recommend that it be created as advertised.

Q Have you studied the proposed deletion from the Blinebry Oil Pool of the acreage listed in the advertisement?

A Yes, I have, and I recommend that it be deleted as advertised.

Q Have you made a study of the proposed deletion from the Blinebry Gas Pool of the acreage listed in the advertisement?

A Yes, sir, I have, and I recommend that it be deleted as advertised.

Q Have you studied the proposed extension of the Terry-Blinebry Pool?

A Yes, and I recommend it be extended as advertised.

Q Have you made a study of the proposed extension of the Caprock-Queen Pool?

A Yes. I recommend that it be extended as advertised, and also the following unitized portions, being the southeast quarter of the northeast quarter of Section A and the west half and the northeast quarter of Section 20 of Township 14 South, Range 31 East, and the north half of the northeast quarter of Section 31, Township 15 South, Range 31 East.

Q Is that contiguous acreage to the present pool?

A That is correct.

W Have you made a study of the proposed extension of the Eumont Pool?

A Yes, I have. I recommend that it be extended as advertised and also the following unitized portions, being the northwest quarter of Section 15, the east half of the southeast quarter of Section 27, Township 19 South, Range 37 East, and all of Section 14, Township 20 South, Range 37 East.

Q Is that unitized portion that you have just recommended contiguous acreage to the present limits of the pool?

A Yes.

Q Have you had an opportunity to study the proposed extension of the vertical limits of the Leo Pool to include the Queen formation and the proposed extension of the pool boundary as advertised?

A Yes, I have, I recommend that it be extended as advertised.

Q Have you made a study of the extension of the Loco Hills Pool?

A Yes, sir, I have, and I recommend it be extended as advertised.

Q Have you made a study of the proposed extension of the North Mason-Delaware Pool?

A Yes, and I recommend it be extended as advertised.

Q Have you made a study of the proposed extension of the vertical limits of the Palmillo Pool to include the Grayburg formation, as advertised?

A Yes, I have, and I recommend that it be extended as advertised.

Q Have you in your official capacity made a study of the proposed extension of the Red Hills-Yates Pool?

A Yes, sir, I have, and recommend it be extended as advertised.

Q Do you have the exhibits on which you base your proposals?

A Yes, sir. I wish to submit to the Commission exhibits Nos. A through E and G through Q.

Q Did you prepare these exhibits, or were they prepared under your direction?

A Yes, sir, they were.
