TRANSCRIPT OF PROCEEDINGS

MR. PORTER: The case to be taken up next is Case 1190.

MR. GURLEY: Case 1190. Northwestern New Mexico nomenclature case calling for the extension of existing pools in San Juan and Rio Arriba Counties, New Mexico.

ELVIS A. UTZ

a witness, of lawful age, having been first duly sworn on oath, testified as follows:

DIRECT EXAMINATION

By MR. GURLEY:

Q State your name, please.

A Elvis A. Utz, engineer with the Oil Conservation Commission.

Q Have you testified before this Commission before, Mr. Utz?

A Yes, sir.

Q You, in your official capacity as an engineer for the Oil Conservation Commission of New Mexico, had an opportunity to study the proposed extension of the Ballard-Pictured Cliffs Pool?

A Yes, I have, and I recommend that the Ballard-Pictured Cliffs Pool be extended on the basis of two wells producing from this formation.

Q Do you have an exhibit?

A I will submit the exhibit when we are through with the testimony.

Q Have you marked that exhibit, Mr. Utz?

A Yes, sir, Exhibit No. 1.

Q Have you, in your official capacity, had an opportunity to study the proposed extension of the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico?

A Yes, and I recommend that the South Blanco-Pictured Cliffs Pool be extended on the basis of two wells capable of producing from the Pictured Cliffs formation.

Q Do you have an exhibit to substantiate your testimony?

A Yes, sir.

Q That is Exhibit 2?

A That is Exhibit 1.

Q It is also Exhibit 1?

A That is correct.

Q Have you, in your official capacity, had an opportunity to study the proposed extension of the Blanco-Mesaverde Pool?

A Yes, I have, and I recommend that the Blanco-Mesaverde Gas Pool be extended as advertised on the basis of one well capable of producing from this formation.

Q Have you, in your official capacity, had an opportunity to study the extension of the Bisti-Lower Gallup Oil Pool?

A Yes, I have, and I recommend that the Bisti-Lower Gallup Oil Pool be extended as advertised on the basis of one well capable of producing from this formation.

Q Did you have your exhibits to enter at this time?

A I submit Exhibit 1, which lists all the extensions as advertised, together with the wells on which these extensions are based.

Q Was this exhibit prepared under your direction?

A It was prepared under my direction and checked.

MR. GURLEY: That is all.

MR. PORTER: Without objection, the exhibit will be admitted. Any questions of Mr. Utz?

Does anyone else have anything further in this case?
The witness may be excused.

(Witness excused).


MR. PORTER: The case will be taken under advisement.
