BY: MR. COOLEY:

Q State your name and occupation for the record, please.

A Elvis A. Utz, engineer for the Oil Conservation Commission.

Q Mr. Utz, have you in your official capacity for the New Mexico Oil Conservation Commission had an opportunity to study the nomenclature case calling for the extension of existing pools in San Juan and Rio Arriba <sup>C</sup>ounties, New Mexico?

A Yes, I have.

Q Do you have any recommendation concerning extension of the South Blanco-Pictured Cliffs Pool?

A Yes, I have. I recommend that the South Blanco-Pictured Cliffs Pool be extended as advertised on the basis of four wells capable of producing from this pool.

Q What recommendations do you have concerning the extension of the Fulcher Kutz-Pictured Cliffs Pool?

A I recommend that the Fulcher-Kutz-Pictured Cliffs Pool be extened as advertised on the basis of one well producing from this pool.

Q Have you any recommendations concerning the extension of the Gavilan-Pictured Cliffs Pool?

A I recommend that the Gavilan-Pictured Cliffs Pool be extended as advertised on the basis of two wells capable of producing from this pool.

Q What are your recommendations concerning extension of the Otero-Pictured Cliffs Pool?

A I likewise recommend that the Otero-Pictured Cliffs Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q What are your recommendations concerning extension of the West Kutz-Pictured Cliffs Pool?

A I recommend that the West Kutz-Pictured Cliffs Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q Do you have any recommendations concerning the extension of the Blanco Mesaverde Pool?

A ,Yes, I recommend that the Blanco Mesaverde Pool be extended as advertised on the basis of seven wells capable of producing from this pool.

Q What are your recommendations concerning extension of the Bisti Lower Gallup Oil Pool?

A I recommend that the Bisti Lower Gallup Oil Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q Do you have any recommendations concerning the extension of Verde Gallup Oil Pool?

A I recommend that the Verde Gallup Oil Pool be extended as

advertised on the basis of two wells capable of producing from this pool.

Q Do you have any further recommendations?

A I have no further recommendations in this case. I do have an exhibit I would like to submit, which shows the extensions recommended, together with the pools, and the wells on which they are based.

Q And is that identified as Exhibit 1?

A Yes, sir, it is.

MR. COOLEY: I would like to offer Exhibit 1 into evidence.
