## ORDER OF THE COMMISSION

# BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on March 14, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this  $23^{Rd}$  day of April, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

### FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Fulcher Kutz-Pictured Cliffs Pool, the West Kutz-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico and to the Gavilan-Pictured Cliffs Pool and the Otero-Pictured Cliffs Pool, both in Rio Arriba County, New Mexico, and to the South Blanco-Pictured Cliffs Pool and the Blanco Mesaverde Pool, both in Rio Arriba and San Juan Counties, New Mexico.

#### IT IS THEREFORE ORDERED:

(a) That the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 27 NORTE, RANGE 7 WEST, NMPM Section 5: S/2 Section 8: All Section 13: NW/4 and SE/4

(b) That the Fulcher Kutz-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 28 NORTH, RANGE 11 WEST, NMPM Section 15: SW/4 Section 16: SE/4

(c) That the Gavilan-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 25 NORTH, RANGE 2 WEST, NMPM Section 24: All

(d) That the Otero-Pictured Cliffs Pool in Rio Arriba County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 24 NORTH, RANGE 6 WEST, NMPM Section 1: SE/4

(e) That the West Kutz-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 27 NORTH, RANGE 10 WEST, NMPM Section 29: SE/4

(f) That the Blanco Mesaverde Pool in San Juan and Ric Arriba Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 26 NORTH, RANGE 3 WEST, NMPM Sections 1 through 36: All

> TOWNSHIP 26 NORTH, RANGE 4 WEST, NMPM Section 1: All Section 2: All Sections 11 through 14: All Sections 23 through 26: All

(g) That the Bisti-Lower Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 26 NORTH, RANGE 13 WEST, NMPM Section 33: All

(h) That the Verde-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:


