Dear Randall:

As you know, the Commission heard Cases 1253 and 1254 on May 16th in Hobbs. The applications in these cases requested 80-acre spacing, definition of the vertical and horizontal limits of the pool and a location pattern.

The testimony presented in these cases is now under consideration and a decision will be forthcoming in the near future, but until such time as the decision is announced, you are hereby directed to approve only notices of intention to drill which show the well locations as being in the NE/4 or the SW/4 of the quarter section (within 150 feet of the center of the unit). This should apply to all locations which are projected to the Wolfcamp formation within one mile of the horizontal area recommended by the Tennessee Gas Transmission Company at the hearing.

Gentlemen:

Enclosed is a copy of our Exhibit No. 13 introduced in the Kemnitz Area hearing of May 16, 1957, in Hobbs, New Mexico. In accordance with your request of that date, we have labeled each point to indicate the well from which the data was determined. Also enclosed is a tabulation of the calculation of acre-foot recoveries on each well used in the preparation of the curve.

Recovery for each of the wells was determined from analysis of individual decline curves. Because there were no wells completed after December, 1954, in the area of the Townsend field used for analogy purposes, it was necessary to use reserves of wells which exhibited similar performance history in other parts of the field in order to tie down the latter portion of the curve.

We will be happy to provide any additional data in regard to our testimony at the May 16 hearing that you may desire.
