ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 13, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 28th day of June, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Queen formation, said pool to bear the designation South Corbin-Queen Pool. Said South Corbin-Queen Pool was discovered by the Sunray Mid-Continent Oil Company New Mexico Federal "E" #1, located in the NE/4 SE/4 Section 28, Township 18 South, Range 33 East, NMPM. It was completed September 8, 1956. The depth of the casing shoe is 4,378 feet.

(3) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Yates formation, said pool to bear the designation South Maljamar-Yates Pool. Said South Maljamar-Yates Pool was discovered by the Harvey E. Yates Yates-Buffalo Federal #1, located in the NW/4 NW/4 Section 13, Township 18 South, Range 32 East, NMPM. It was completed April 25, 1957. The top of the perforations is at 3,212 feet.

(4) That there is need for certain extensions to the Anderson Ranch-Devonian Pool, the Eumont Gas Pool, the Jalmat Gas Pool, the Justis Gas Pool, the Penrose-Skelly Pool, the Young Pool,

and the South Carter-San Andres, all in Lea County, New Mexico, to the Cave Pool, the High Lonesome Pool, the Shugart Pool, and the Turkey Track Pool, all in Eddy County, New Mexico, to the Caprock-Queen Pool in Lea and Chaves Counties, New Mexico, and to the Lusk Pool in Lea and Eddy Counties, New Mexico. Further, that the South High Lonesome Pool in Eddy County, New Mexico, and the Carter-San Andres Pool in Lea County, New Mexico, should be abolished.

IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as an oil pool for Queen production, be and the same is hereby created and designated as the South Corbin-Queen Pool, consisting of the following described area:

(b) That a new pool in Lea County, New Mexico, classified as an oil pool for Yates production, be and the same is hereby created and designated as the South Maljamar-Yates Pool, consisting of the following described area:

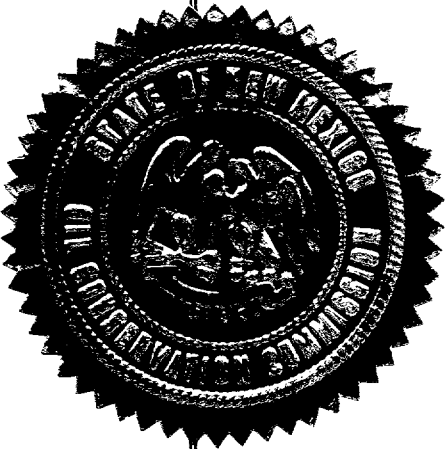
