ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on June 13, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 28th day of June, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the Flora Vista-Fruitland Pool, the Bisti-Lower Gallup Oil Pool, and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico, to the Otero-Chacara Pool, the Otero-Graneros Pool, and the Tapacite-Pictured Cliffs Pool, all in Rio Arriba County, New Mexico, and to the Ballard-Pictured Cliffs Pool, the Blanco Mesaverde Pool, and the South Blanco-Pictured Cliffs Pool, all in San Juan and Rio Arriba Counties, New Mexico.

IT IS THEREFORE ORDERED:

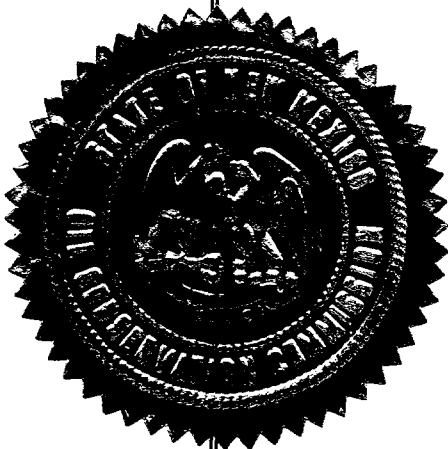
