ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 1 o'clock p.m. on August 28, 1957, at Hobbs, New Mexico, before Daniel S. Nutter, Examiner duly appointed by the New Mexico Oil Conservation Commission, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 16th day of September, 1957, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel S. Nutter, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.

(2) That Gulf Oil Corporation is the owner and operator of an oil and gas lease, a portion of which consists of the SW/4 of Section 30 and the N/2 of Section 31, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico.

(3) That the applicant is the owner and operator of the H. T. Mattern "B" Well No. 10, located 660 feet from the North line and 1980 feet from the West line of said Section 31.

(4) That the N/2 of said Section 31 has already been approved by the Commission as a non-standard gas proration unit dedicated to the said H. T. Mattern "B" Well No. 10.

(5) That the applicant proposes to enlarge the present proration unit for the said H. T. Mattern "B" Well No. 10 to include the SW/4 of Section 30.

(6) That approval of the proposed non-standard gas proration unit will not cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

(1) That a 468-acre non-standard gas proration unit in the Eumont Gas Pool consisting of the SW/4 of Section 30 and the N/2 of Section 31, Township 21 South, Range 37 East, NMPM, Lea County, New Mexico, be and the same is hereby established, said unit to be dedicated to the applicant's H. T. Mattern "B" Well No. 10, located in the NE/4 NW/4 of said Section 31.

(2) That the said H. T. Mattern "B" Well No. 10 be granted an allowable in the proportion that the acreage in the above-described unit bears to the acreage in a standard gas proration unit in the Eumont Gas Pool subject to the provisions of Rule 8 of the Special Rules and Regulations for the Eumont Gas Pool.
