called as a witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

BY: MR. COOLEY:

- State your name and position, please.
- A Elvis A. Utz, engineer with the New Mexico Oil Conservation Commission.
- Mr. Utz, in your official capacity as gas engineer for the New Mexico Oil Conservation Commission, have you had an opportunity to study conditions in oil and gas pools in Northwestern New Mexico?
 - A Yes, sir, I have.
- Mr. Utz, are you aware that there were certain errors in Paragraph B and D in the advertisement of this case in the Farmington paper?
 - A Yes, I am.
 - 2 Do you know whether these errors in advertisement were

corrected and readvertised more than ten days prior to the hearing of this case?

- A It is my understanding that they were.
- Mr. Utz, do you have any recommendations concerning the extension of the Blanco Mesaverde Pool?
- A Yes, I recommend that the Blanco Mesaverde gas pool be extended as advertised on the basis of two wells completed in this pool.
- Do you have any recommendations concerning the extension of the Aztec-Pictured Cliffs Pool?
- A I recommend that the Aztec-Pictured Cliffs gas pool be extended as advertised on the basis of four wells completed in this pool.
- Q And what are your recommendations concerning the Canyon Largo-Pictured Cliff's Pool?
- A Trecommend that the Conyon Largo-Pictured Cliffs gas pool be extended as advertised on the basis of three wells completed in this pool.
- Q Do you have any recommendations concerning the extension of the South Blanco-Pictured Cliffs Pool?
- A Yes, I recommend that the South Blanco-Pictured Cliffs gas pool be extended as advertised on the basis of eleven wells completed in this pool.
 - Q Do you have any recommendations concerning the extension

of the Tapacito-Pictured Cliffs Pool?

- A I also recommend that the Tapacito-Pictured Cliffs gas pool be extended as advertised on the basis of three wells completed in this pool.

- A I recommend that the Bisti-Lower Gallup Oil Pool be extended as advertised on the basis of one well completed in this pool.
