# ORDER OF THE COMMISSION

### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on November 14, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 27th day of November, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the Bisti-Lower Gallup Gil Pool, and the Verde-Gallup Gil Pool, all in San Juan County, New Mexico, to the Canyon Largo-Pictured Cliffs Pool and the Tapacito-Pictured Cliffs Pool, both in Rio Arriba County, New Mexico, and to the Blanco Mesaverde Pool and the South Blanco-Pictured Cliffs Pool, both in San Juan and Rio Arriba Counties, New Mexico.
