ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 13, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 20 day of February, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, and to the Verde-Gallup Oil Pool, all in San Juan County, New Mexico, to the East Blanco-Pictured Cliffs Pool and the Tapacito-Pictured Cliffs Pool, both in Rio Arriba County, New Mexico, and to the Ballard-Pictured Cliffs Pool and the South Blanco-Pictured Cliffs Pool, both in San Juan and Rio Arriba Counties, New Mexico. Further, that a part of the proposed extension of the South Blanco-Pictured Cliffs Pool was advertised in error and should therefore be dismissed.
