ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on August 13, 1958, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," due notice having been given as required by law.

NOW, on this 14th day of August, 1958, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That there is need for certain extensions to the Artesia Pool, the Cave Pool, the Empire-Abo Pool, and the Shugart Pool, all in Eddy County, New Mexico, and to the Anderson Ranch-Wolfcamp Pool, the Bagley-Upper Pennsylvanian Gas Pool, the Blinberry Oil Pool, the Bronco Wolfcamp Pool, the Jalmat Pool, the Roberts Pool, the Tatum-Wolfcamp Pool, the Tubb Gas Pool, and the South Vacuum Devonian Pool, all in Lea County, New Mexico, and to the Caprock-Queen Pool in Chaves and Lea Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Anderson Ranch-Wolfcamp Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:
