In the matter of the application of the Oil Conservation Commission of New Mexico upon its own motion for an order for the creation and extension of existing pools in Lea, Eddy, and Roosevelt Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such extensions and creations should not be made.

(a) Create a new pool in Lea County, New Mexico, classified as an oil pool for Hlinebry production, designated as the Justis-Hlinebry Pool, and described as:

Twp. 25 South, Range 37 East,
SE/4 of Section 13

and such other, etc.

(b) Create a new pool in Lea County, New Mexico, classified as an oil pool for Montoya production, designated as the Justis-Montoya Pool, and described as:

Twp. 25 South, Range 37 East,
SW/4 of Section 13
N/2 of Section 24

and such other, etc.

(c) Create a new pool in Roosevelt County, New Mexico, classified as an oil pool for San Andres production, designated as the Milnesand-San Andres Pool, and described as:

Twp. 8 South, Range 34 East,
NW/4 of Section 24

and such other, etc.

(d) Create a new pool in Lea County, New Mexico, classified as an oil pool for Glorieta production, designated as the Skaggs-Glorieta Pool, and described as:

Twp. 20 South, Range 37 East,
NE/4 of Section 11

and such other, Etc.

dismiss (e) Create a new pool in Lea County, New Mexico, classified as an oil pool for Leonard production, designated as the South Vacuum-Leonard Pool, and described as: *Do not advertise*

Twp. 18 South, Range 35 East,
SE/4 of Section 22

and such other, etc.

(f) Extend the vertical limits of the Bagley-Pennsylvanian Oil Pool in Lea County, New Mexico, to include the following area only:

Twp. 11 South, Range 33 East,
SW/4 SE/4 of Section 34

and redefine the vertical limits of this area to be -4500 feet to -5200 feet subsea. And such other, etc.

(g) Extend the Crosby Devonian Gas Pool boundary in Lea County, New Mexico, to include therein:

Twp. 25 South, Range 37 East,
SE/4 of Section 33

and such other, etc.

(h) Extend the Eumont Pool boundary in Lea County, New Mexico, to include therein:

Twp. 21 South, Range 35 East,
Lots 3, 4, 5, & 6 of Section 3

and such other, etc.

(i) Extend the Grayburg Jackson Pool boundary in Eddy County, New Mexico, to include therein:

Twp. 17 South, Range 31 East,
E/2 NW/4 & W/2 NE/4 of Section 10

and such other, etc.

(j) Extend the Justis-Drinkard Pool boundary in Lea County, New Mexico, to include therein:

Twp. 25 South, Range 37 East,
SW/4 of Section 24

and such other, etc.

(k) Extend the Justis-Fusselman Pool boundary in Lea County, New Mexico, to include therein:

Twp. 25 South, Range 37 East,
SW/4 of Section 13

and such other, etc.

(l) Extend the Maljamar Pool boundary in Lea County, New Mexico, to include therein:

Twp. 17 South, Range 33 East,
SE/4 of Section 18

and such other, etc.

(m) Extend the East Millman-Queen Pool boundary in Eddy County, New Mexico, to include therein:

Twp. 19 South, Range 28 East,
SW/4 of Section 14

Twp. 16 South, Range 36 East,
Lots 3, 4, 5, & 6 of Section 6

and such other, etc.

(o) Extend the South Vacuum-Devonian Pool boundary in Lea County, New Mexico, to include therein:

Twp. 18 South, Range 35 East,
NE/4 of Section 21
W/2 of Section 22

and such other, etc.

(p) Extend the Vacuum-Yates Pool boundary in Lea County, New Mexico, to include therein:

Twp. 17 South, Range 35 East,
NE/4 of Section 34

and such other, etc.
