TRANSCRIPT OF PROCEEDINGS

MR. PORTER: We will proceed at this time to Case 1525.

MR. PAYNE: Case 1525. Southeastern New Mexico nomenclature case calling for an order for the creation of new pools and extension of existing pools in Lea, Eddy and Chaves Counties, New Mexico.

(Witness sworn)

RANDALL MONTGOMERY,

called as a witness, having been first duly sworn on oath, testified as follows:

DIRECT EXAMINATION

BY MR. PAYNE:

- Q Will the witness please state his name and position?
- A Randall Montgomery, proration manager, New Mexico Oil Conservation Commission.
 - Q Mr. Montgomery, in your official capacity with the Oil

Conservation Commission, have you had an opportunity to make a study concerning the desirability or necessity for the creation of new oil pools and extension of existing pools in Lea, Eddy and Chaves Counties, New Mexico?

A I have.

Q What are your recommendations concerning creation of a new oil pool for Devonian production?

A I recommend that that portion advertised as paragraph (a) for the creation of a new oil pool for Devonian production to be named as the Arkansas Junction-Devonian Pool be created as advertised. The reason for this new Pool is the recent discovery of Texas Pacific Coal & Oil Co. State W #1 in Unit D, Section 28, Township 18 South, Range 36 East, completed in the Devonian 7/11/58; top of perforation at 12,140 feet.

Q What do you recommend as the vertical and horizontal limits?

A The Devonian formation for the vertical limits and the NW/4 of Section 28 and the NE/4 of Section 29, Township 18 South, Range 36 East.

Q What are your recommendations concerning creation of a new oil pool for Grayburg production?

A I recommend the pool be created as advertised. The reason for this discovery was the Gulf Oil Corporation Federal Littlefield AA Well #1 located in Unit P of Section 20, Township 18 South, Range 31 East, completed in the Grayburg formation on

5/22/58. Top of perforation was 3,666 feet, The vertical limits of this pool I recommend be the Grayburg formation, the horizontal the SE/4 of Section 20, Township 18 South, Range 31 East, designated as the East Leo-Grayburg Pool.

Q What are your recommendations concerning the creation of a new gas pool for Pennsylvanian production?

A I recommend that the pool be created as advertised on the basis of the recent discovery of The Texas Co. Audie Richards Well #1 located in Unit P of Section 25, Township 20 South, Range 32 East, completed in the Morrow Sand Pennsylvanian on 1/20/58. The top of perforation was 12,909 feet. We recommend that the vertical limits for this pool be designated as the Pennsylvanian, the Pool to be named the South Salt Lake-Pennsylvanian Gas Pool. The horizontal limits to be the SE/4 of Section 25, Township 20 South, Range 32 East.

Q What are your recommendations concerning extension of the Allison-Pennsylvanian Pool?

A I recommend that that pool be extended as advertised on the basis of one well capable of producing from the Pennsylvanian formation.

Q What are your recommendations concerning extension of Atoka Pool?

A I recommend that pool be extended as advertised on the basis of one well capable of producing.

Q What are your recommendations concerning extension of the

Caprock-Queen?

A I recommend that the Caprock-Queen Pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations concerning extension of South Carter-San Andres Pool?

A I recommend that that pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations converning extension of the High Lonesome Pool?

A I recommend that that pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations concerning extension of West Henshaw-Grayburg Pool?

A I recommend that that Pool be extended as advertised on the basis of two wells capable of producing from this Pool.

Q What are your recommendations converning extension of Jalmat Gas Pool?

A I recommend that Pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations concerning extension of the South Paddock Pool?

A I recommend that the pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations concerning extension of

Reeves-Pennsylvanian Pool?

A I recommend this Pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations concerning extension of the South Sawyer-San Andres Pool?

A I recommend that that pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations concerning extension of Square Lake Pool?

A I recommend that this Pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q What are your recommendations converning extension of the Young Pool?

A I recommend that Pool be extended as advertised on the basis of one well capable of producing from this Pool.

Q Mr. Montgomery, have you prepared exhibits substantiating your recommendations?

A I have, and I have marked these Exhibits 1 through 16.

MR. PAYNE: Mr. Examiner, I move that Exhibits 1 through 16 in Case 1525 be received in evidence.

MR. PORTER: Without objection, Exhibits 1 through 16 will be received. Anyone have any questions of Mr. Montgomery?
